RE: PC10 End of Life Notification & Amendment to Distributor Agreement

Dear Distributor,

On or about May 31, 2013 you received notification that Maxwell Technologies, Inc. ("Maxwell") had elected to discontinue the manufacture and sale of our PC10 product line. In an effort to accommodate the needs of our valued business partners, we have extended the last time buy window an additional three months; as such, all orders for PC10 products must be submitted to Maxwell no later than December 31st, 2013 and delivery must be taken by June 30th, 2014. This letter shall serve as written notice as required by the Distributor Agreement.

In addition to extending the last time buy window, we are pleased to inform you that we have reduced the PC10 pricing. Enclosed you will find an Amendment to the Distributor Agreement updating the Products and Pricing contained in Exhibit A as well as other modifications to the Agreement, signed in duplicate.
