Packaging update for NICs to consolidate labeling.

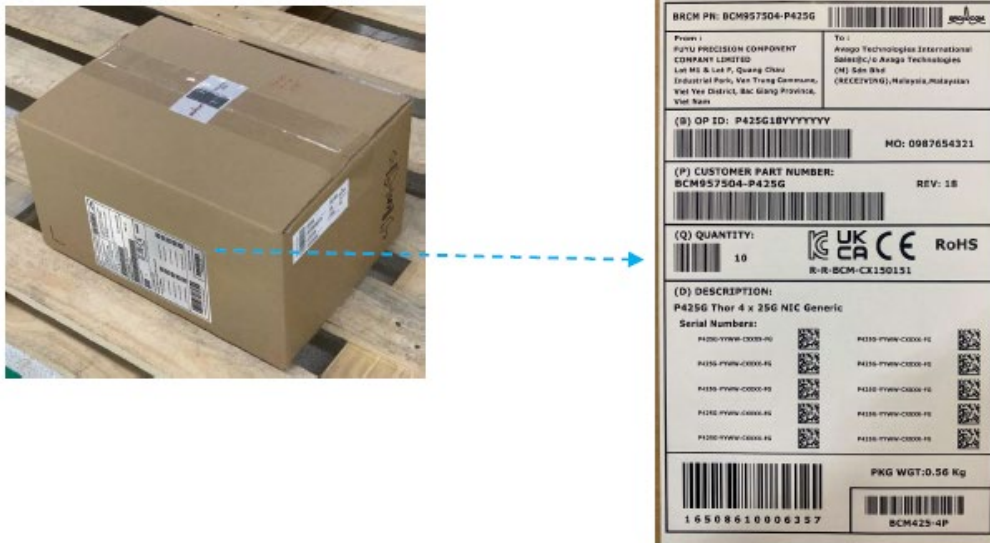
Description and Extent of Change:
