Found DU/MLQ difference between packaging standard vs SAP .

Lincoln was packing these terminals in large cylinder packs and the SCH where managing break packs according to customer request.

## After -Change In DU & MLQ for KK Shoot and ship Terminals

- Molex Lincoln/Little rock and Molex India both plants produces KK series of terminals. We observed that the packaging DU & MLQs are different between the two plants for KK series.
- "No impact to fit, form or function"
- The KK series 104 part numbers affected "see attached impacted parts list" attached.
