PCN OVERVIEW

- As a valued customer, Molex is notifying you we are shortening the component supply chain to minimize risk and maintain & improve delivery performance
- Continuing our strategy started several years ago, Molex Consumer & Commercial Solutions (CCS) Division will transfer conventional injection molded component tooling from Lincoln, Nebraska to Nogales, Mexico where they are currently consumed and transformed into the finished goods you purchase

- Going forward, Nogales, Mexico plant will manufacture their own molded components instead of receiving them from Lincoln.

PCN DETAILS

- **We are shortening the component supply chain to maintain and improve delivery performance. Shipments of component injection molds will start in August 2024 and conclude in September 2024.**
 - Only production molds are being transferred.
 - No resin supplier changes are being made. Resin will continue to be sourced from the same supplier and manufacturing location
- **Product Impact** – None, no change to form, fit or function
