- Molex is notifying you we are continuing our manufacturing footprint optimization and production consolidation process.
- Starting in August 2025, Molex will begin transferring assembly equipment and supporting component injection molds from our US Lincoln, Nebraska plant to our plant located in Nogales, Mexico.
