Description	With the aim of continuously optimizing production capacity and offering our Customers an agile and integrated service, we decided to restart the massive production of PENTAWATT and HEPTAWATT products in the manufacturing line of ST BOUSKOURA (Morocco). The production in ST BOUSKOURA plant will be using exactly the same B.O.M. list currently in use in ST LONG GANG (China) plant.

WHAT:

The Pentawatt and Heptawatt products **L200CV**, **L4960** and **L4962E/A**, currently manufactured in ST Long Gang plant in China, will be moved back to ST Bouskoura plant in Morocco for the assembling and testing & finishing operations.

WHY:

To achieve the optimization of the production capacity in ST Bouskoura plant.

HOW:

The above mentioned products will be transferred from ST Long Gang back to ST Bouskoura where they were already in full production.

The Back-End relocation will not affect the electrical, dimensional and thermal parameters of the products, keeping unchanged all information reported on the relevant datasheets. There will be as well no change in the packing process nor in the standard delivery quantities.

A new Finished Goods code will identify the new assembly in ST Bouskoura, as shown below:
