

<b>VALIDATION</b>	<p>Validation is performed through a correlation exercise, as normally foreseen for EWS site transfer methodology. Apart from the physical location, test environment adopted in Singapore replicates the one currently running in ST Agrate site (software and hardware models).</p> <p>Qualification is run probing the same wafer, correlating wafer maps, binning and statistics, further to standard spike analysis.
