RoHS exemption 6c (lead as an alloying element in copper at concentrations of up to 4% by weight) will now expire uniformly on 30 June 2027 for most electrical and electronic equipment. All the products and components mentioned are being converted to lead-free versions, which comply with the required guidelines without exception.
