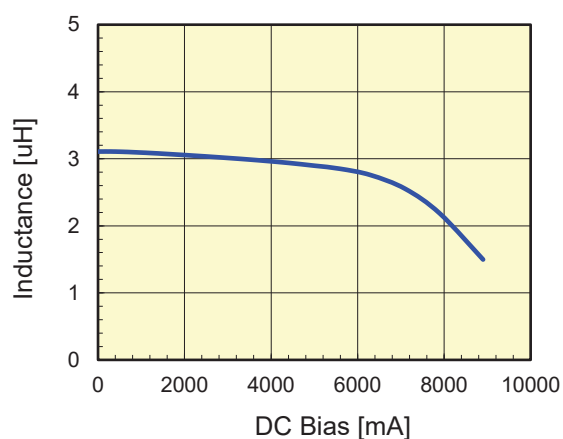

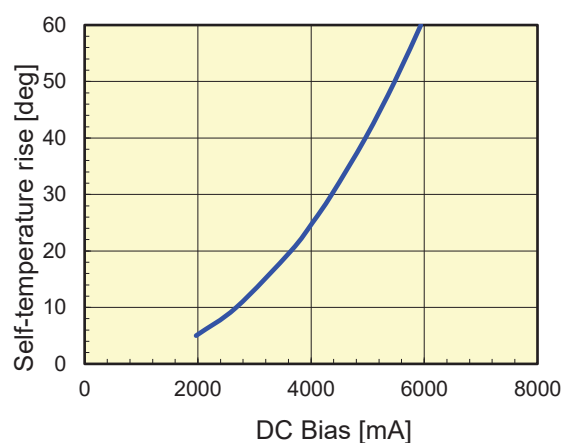

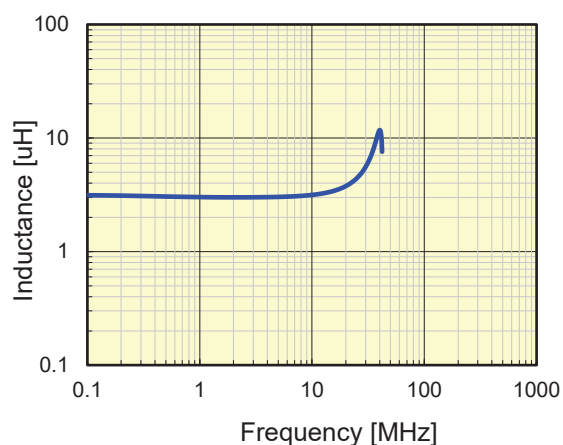
DC Bias vs Inductance
