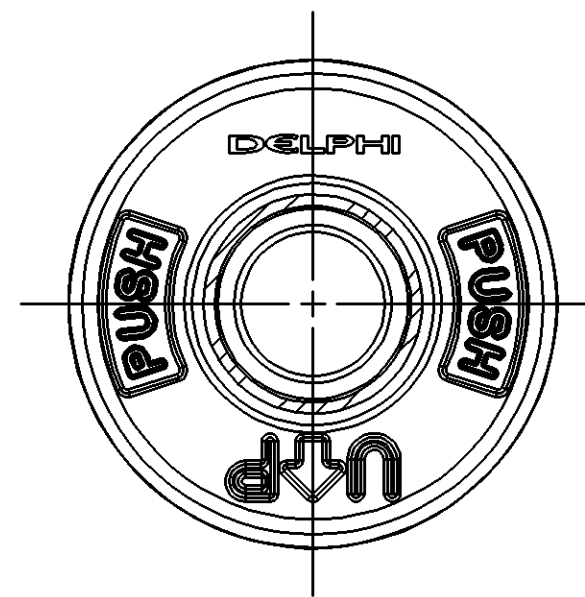
MOUNTING HOLE DETAIL (DOOR)



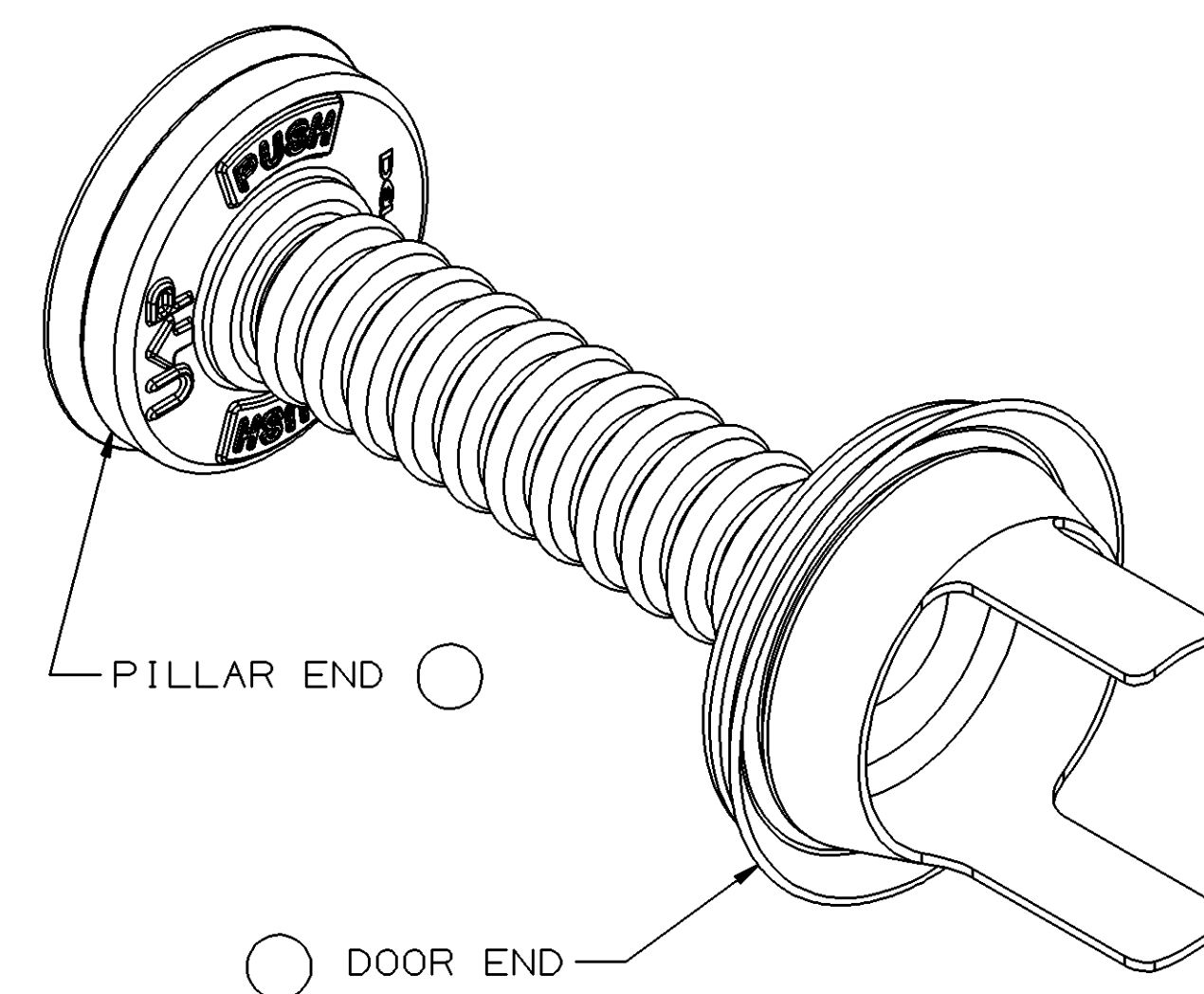
MOUNTING HOLE DETAIL (PILLAR)

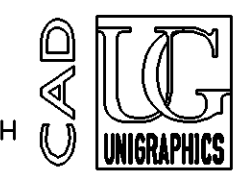
