



Description

The AP2318A is a series of ultra low dropout regulators optimized for low voltage applications where transient response and minimum input voltage are critical.

The AP2318A provides current limit and thermal shutdown function. Its circuit includes a trimmed bandgap reference to assure output voltage accuracy to be within ±1.5%. On-chip thermal shutdown provides protection against any combination of overload and ambient temperatures that would cause excessive junction temperatures.

The AP2318A has adjustable version, which can set the output voltage through two external resistors.


The AP2318A is available in the standard DFN-3x3-8 and PSOP-8 packages.



(Top View)





Typical Applications Circuit





The maximum allowable power dissipation is a function of the maximum junction temperature, T_J(Max), the junction-to-ambient thermal resistance, θ_{JA}, and the ambient temperature, T_A. The maximum allowable power dissipation at any ambient temperature is calculated using: P_D(Max) = (T_J(Max)-T_A)/θ_{JA}. Exceeding the maximum allowable power dissipation will result in excessive die temperature, and the regulator will go into thermal shutdown.






Output Voltage vs. Input Voltage




Supply Current vs. Input Voltage




Supply Current vs. Output Current




Output Voltage vs. Output Current



Supply Current vs. Case Temperature













Dropout Voltage vs. Output Current






PSRR vs. Frequency













Package Outline Dimensions (Cont. All dimensions in mm(inch).)
