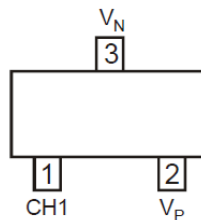

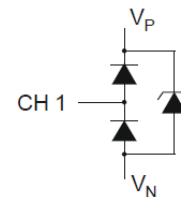

Pin Configuration



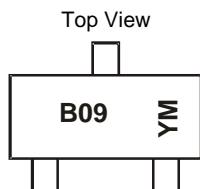
Device Schematic

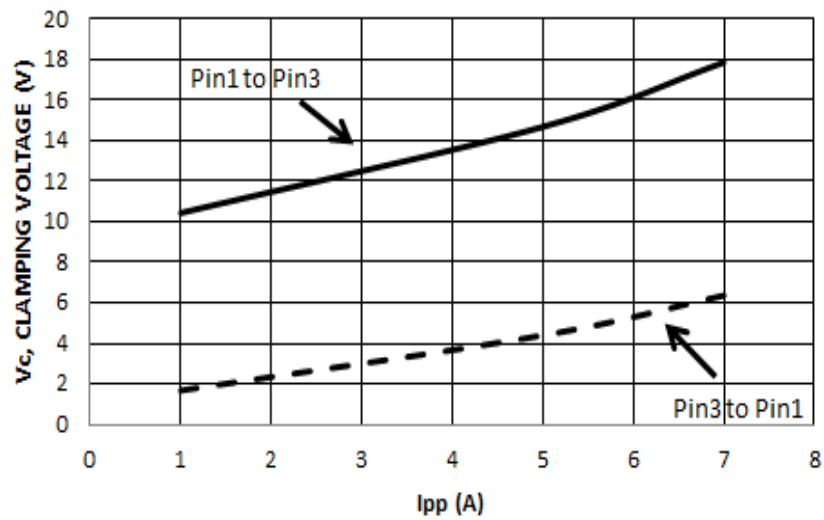


Figure 7 Clamping Voltage Characteristics ( $t_p=8/20\mu s$ )

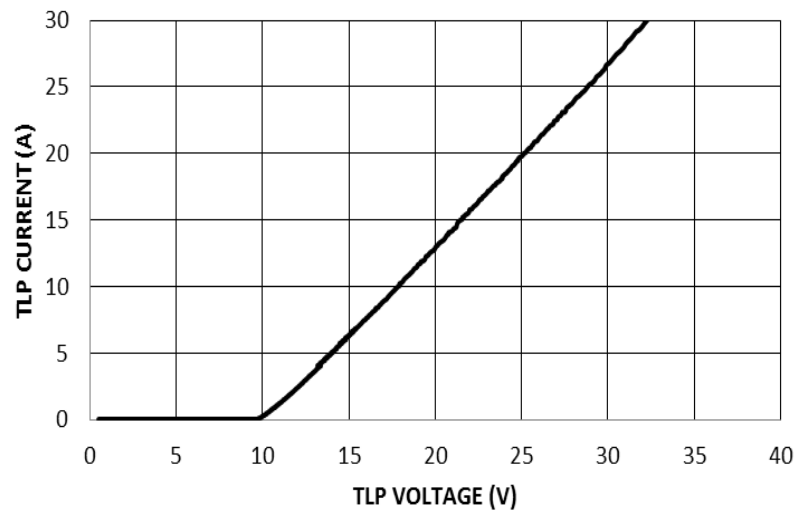
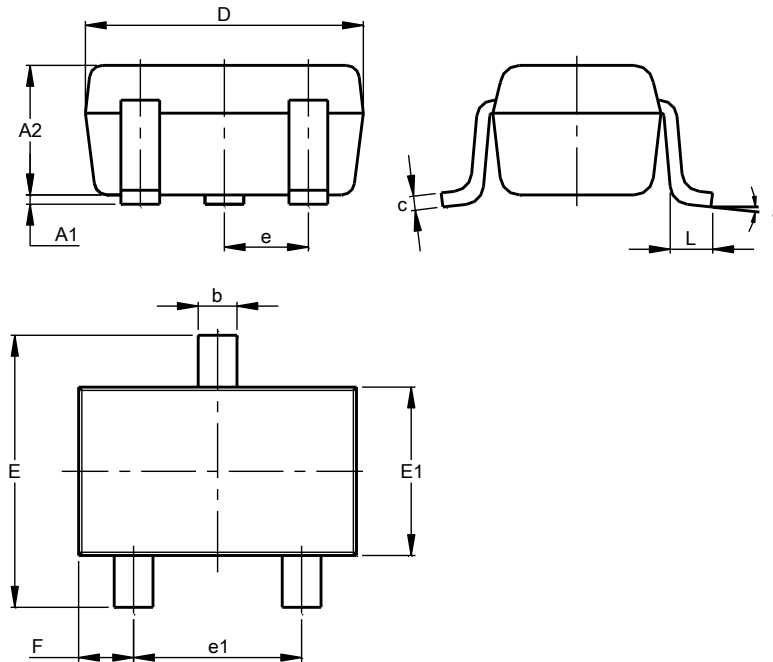


Figure 8 TLP Curve ( $t_p=100ns$ )

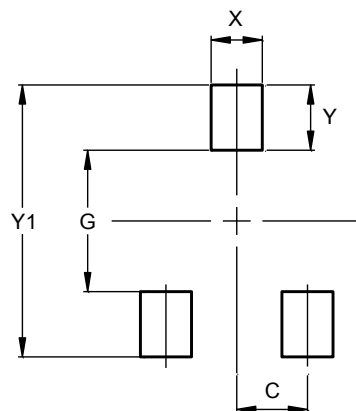
