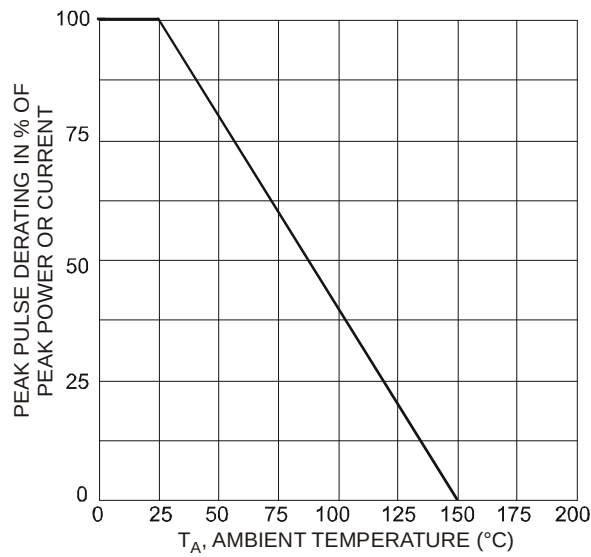


Figure 1 Pulse Derating Curve

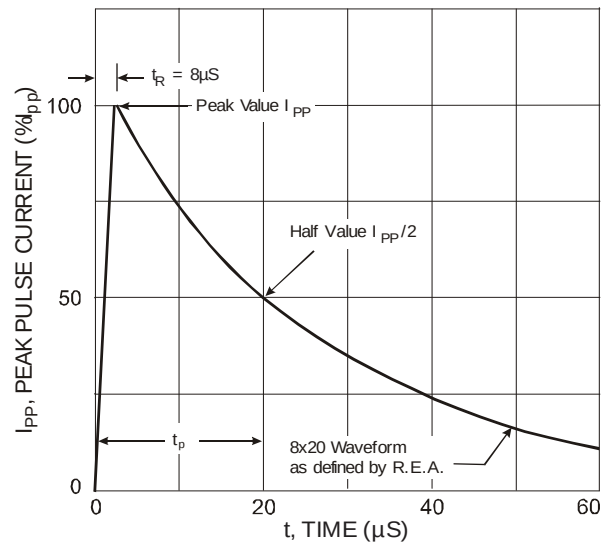


Figure 2 Pulse Waveform

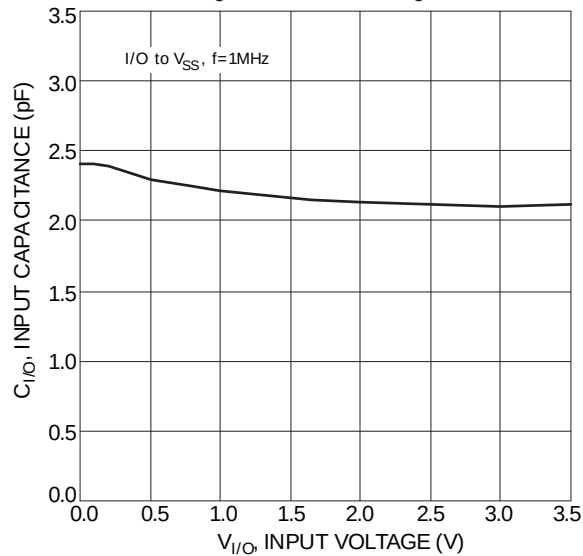


Figure 3 Input Capacitance vs. Input Voltage

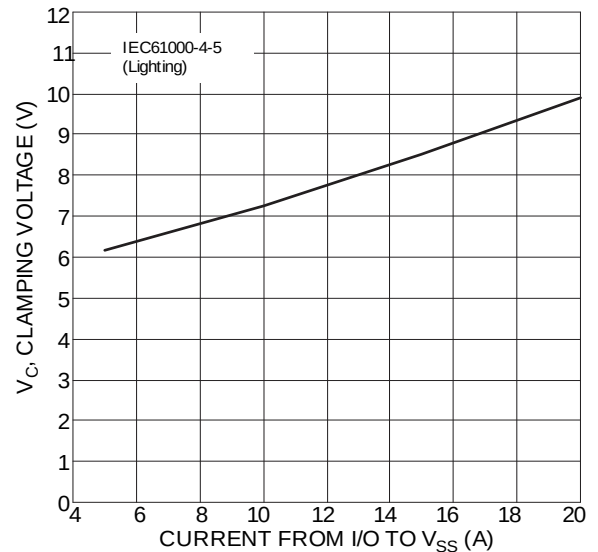


Figure 4 Clamping Voltage Characteristic

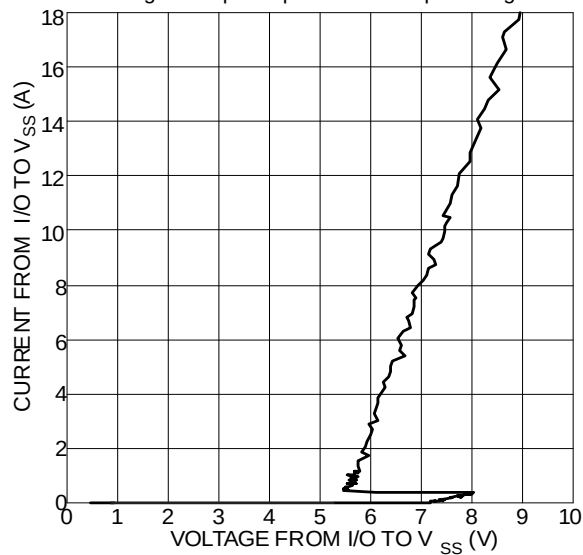
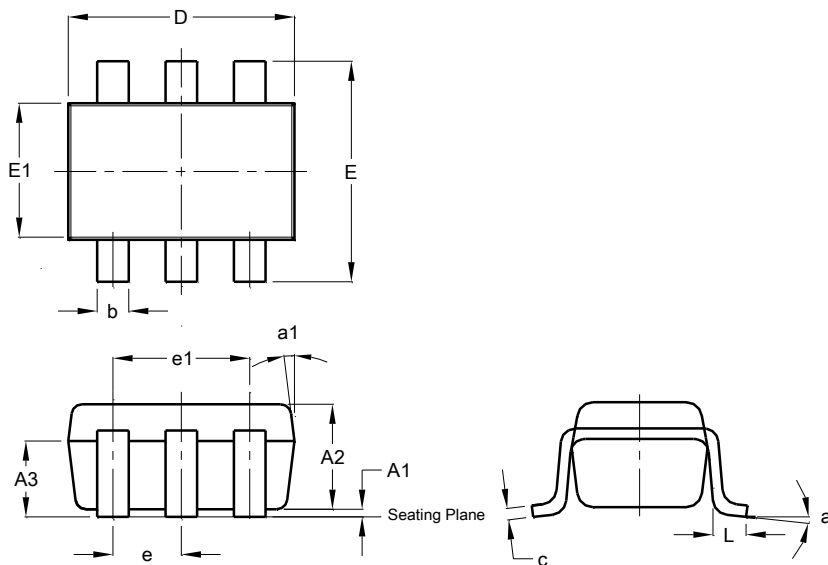


Figure 5 Current vs. Voltage

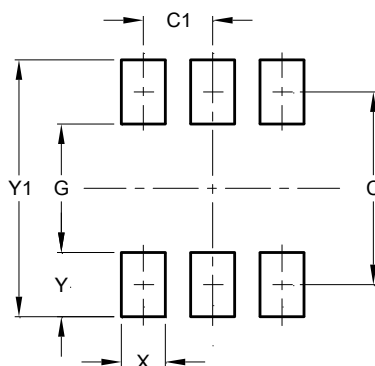
