USB Evaluation Cable for EPSON IMU

OVERVIEW

The USB Evaluation Cable enables a PC to control an Epson IMU via USB interface when connected to a USB Evaluation Cable Interface Board (M-G35EV022, M-G32EV031, or M-V34EV021). The USB Evaluation Cable Interface Boards are sold separately. These USB evaluation tools simplify the initial evaluation and rapid testing of the Epson IMU products.

BLOCK DIAGRAM

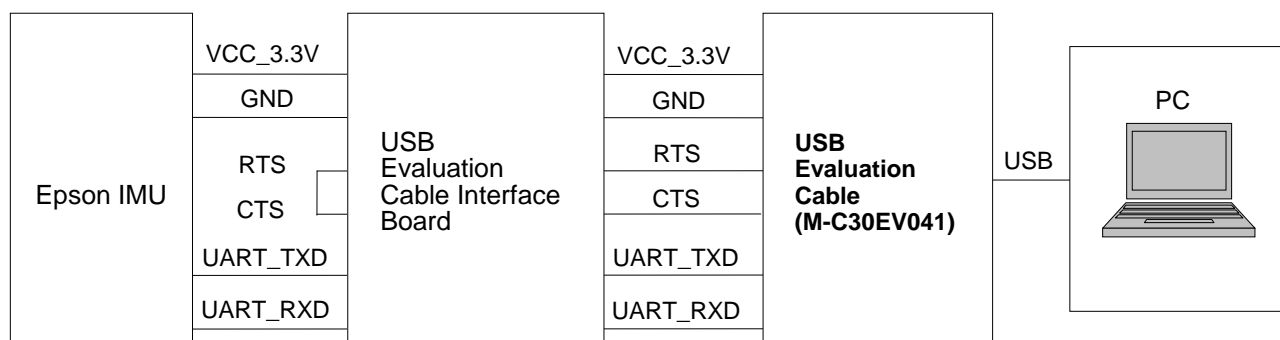


Fig1. Block Diagram

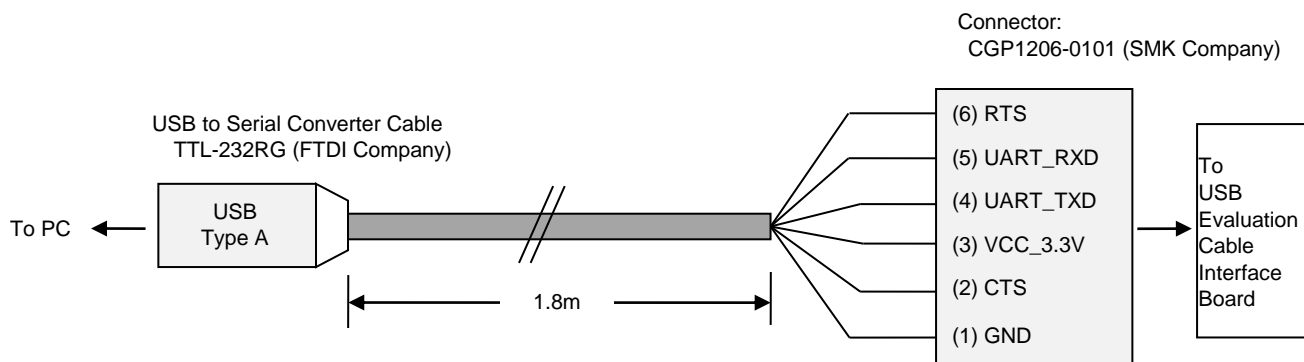


Fig2. Cable Diagram

- Access the FTDI website (<http://www.ftdichip.com/Drivers/VCP.htm>) and download the appropriate driver for the OS.

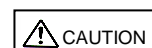

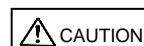
