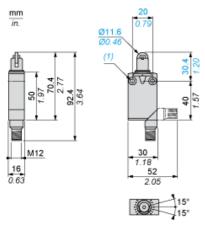

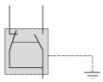

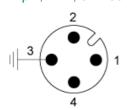
Wiring Diagram

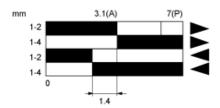

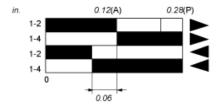
