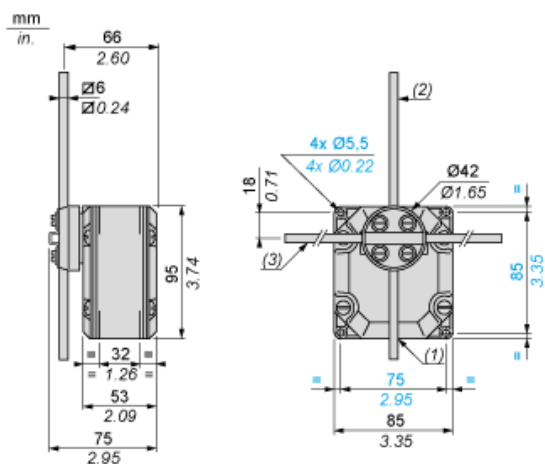

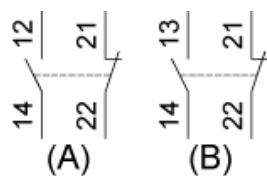

- (3) Rod length: 300 mm.

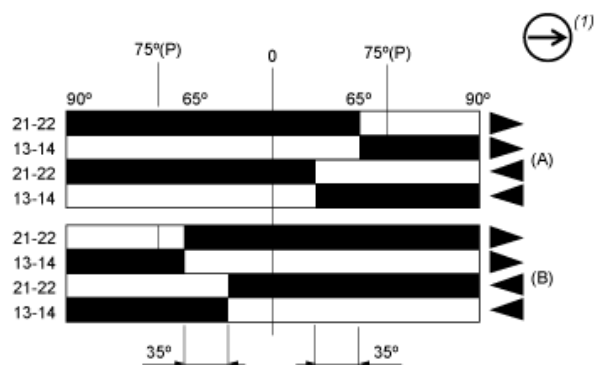
Wiring Diagram
