





### **RELATIVE SPECTRAL SENSITIVITY vs. WAVELENGTH**










Collector Current vs.














#### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**

#### **REEL DIMENSION** (units: mm)


