




Surge Voltage 1.

Absolute maximum voltage, non-repetitive. Duration not to exceed 1 second.

- "Typical" values represent mean values of production sample.
- Rated Capacitance & $\mathsf{ESR}_{\mathsf{DC}}$ (measure method) 3.
 - \bullet Capacitance: Constant current charge (per datasheet) to $V_{_{\rm R}},$ 5 min hold at $V_{_{\rm R}},$ constant current discharge 10 mA/F to 0.1V.
 - ESR_{no}: Constant current charge (per datasheet) to V_R, 5 min hold at V_R, constant current discharge (40 * C * V_R[mA]) to 0.1 V.



- Temperature Rise at Constant Current
 - $\Delta T = I_{RMS}^2 x ESR_{DC} x R_{th}$

where ΔT: Temperature rise over ambient (°C) $I_{\rm RMS}$: Maximum continuous or RMS current (A) $R_{\rm th}$: Thermal resistance, cell to ambient (°C/W) ESR_{DC} : Rated (Max.) $ESR_{DC}(\Omega)$. (Note: Design should consider EOL ESR_{pc} for application temperature rise


