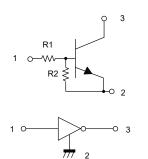
Internal Structure

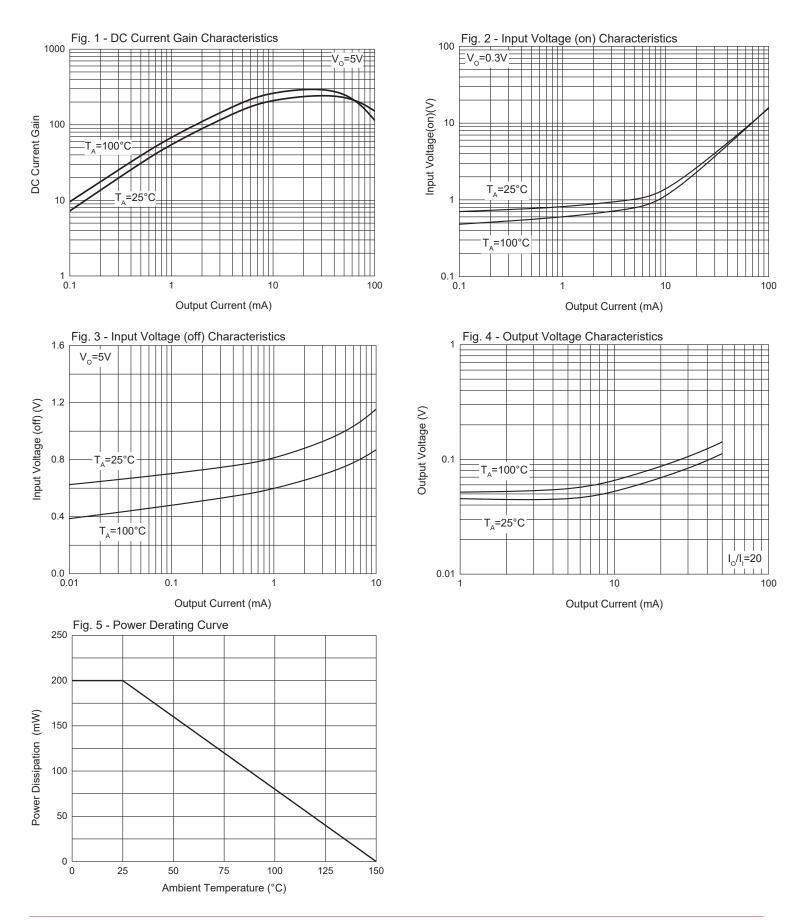
