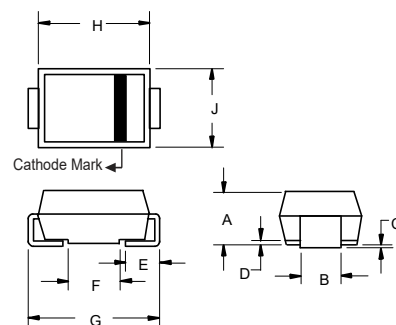

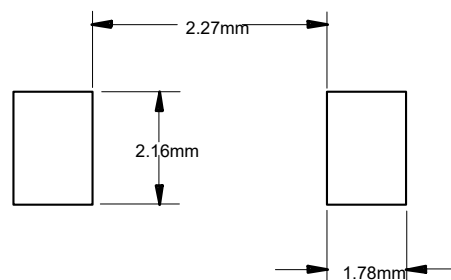

Fig. 1 - Power Derating Curve

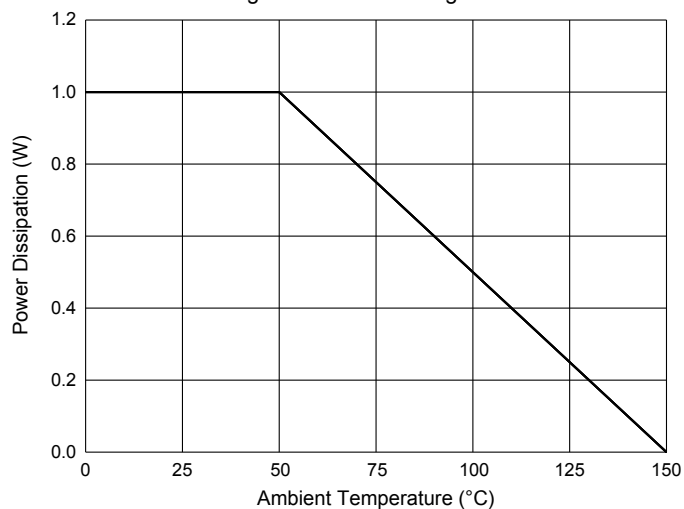


Fig. 2 - Typical Zener Breakdown Characteristics

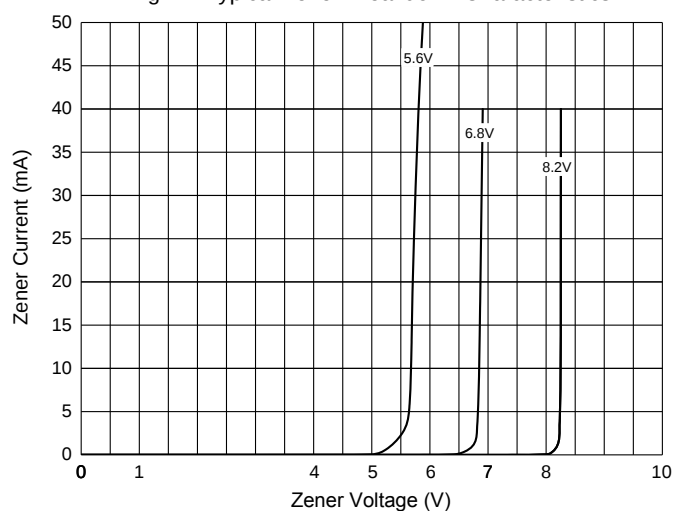
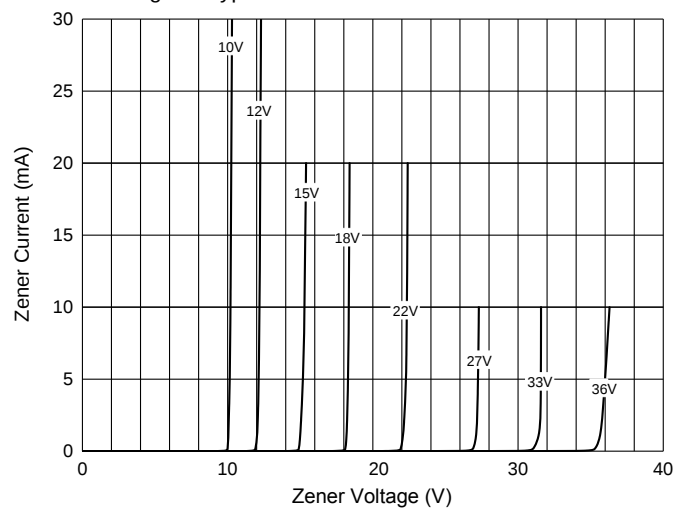


Fig. 3 - Typical Zener Breakdown Characteristics
