




Fig. 3 - Typical Instantaneous Forward Characteristics





Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current 45 40 Peak Forward Surge Current (A) 35 30 25 20 15 10 5 8.3 ms Single Half Sine-Wave 0 100 Number of Cycles at 60 Hz
