

### L-BAND 4 W SINGLE CONTROL HIGH POWER SPDT SWITCH

#### DESCRIPTION

The  $\mu$ PG2156TB is an L-band single control SPDT GaAs FET switch which was developed for digital cellular or cordless telephone application. The device can operate from 800 MHz to 2.5 GHz, having the low insertion loss and high linearity.

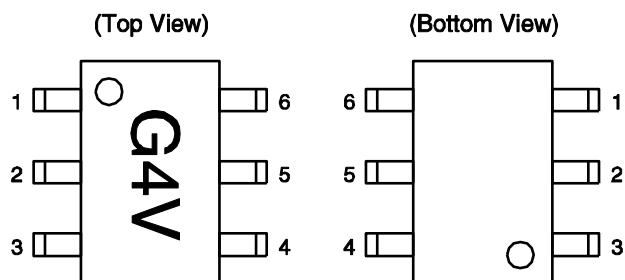

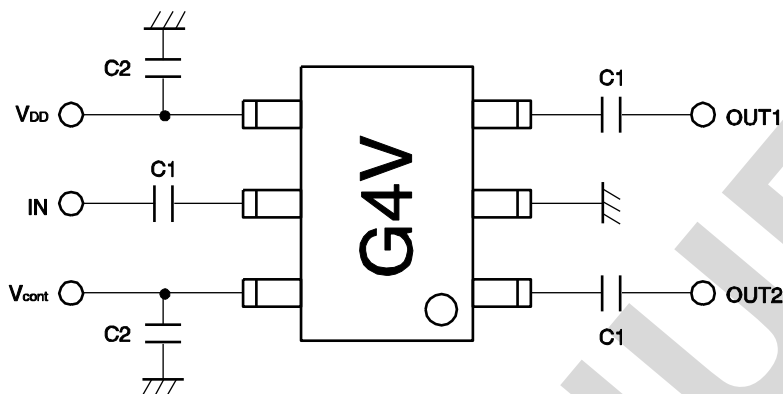

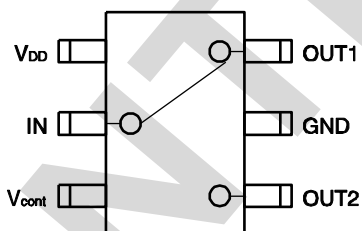
## EVALUATION CIRCUIT

The application circuits and their parameters are for reference only and are not intended for use in actual design-ins.

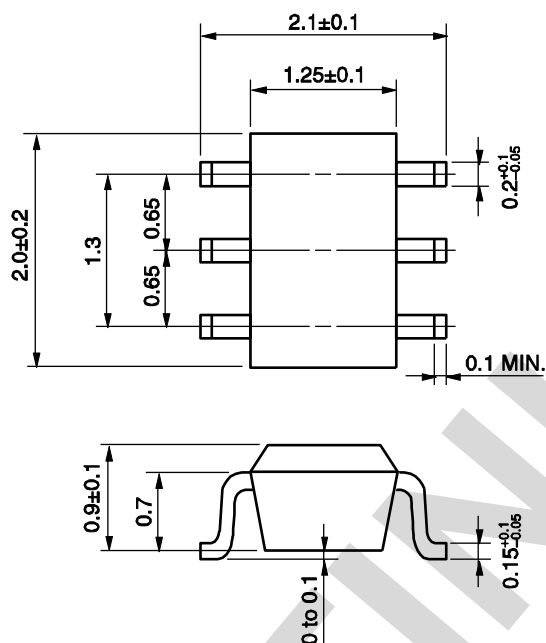
