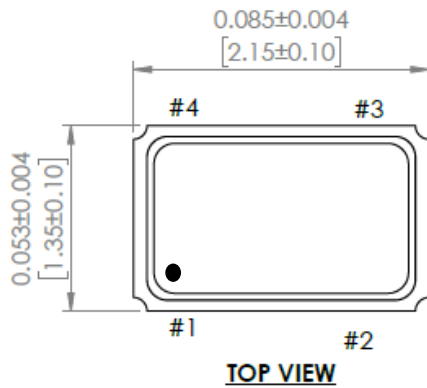

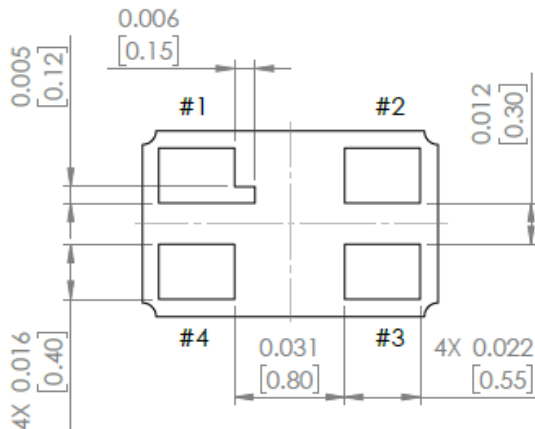

TOP VIEW

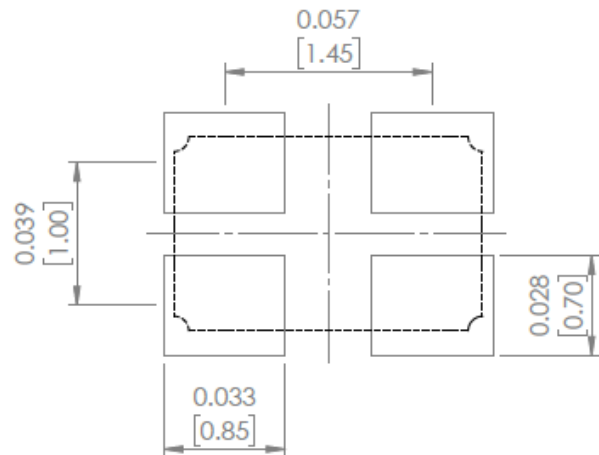


SIDE VIEW

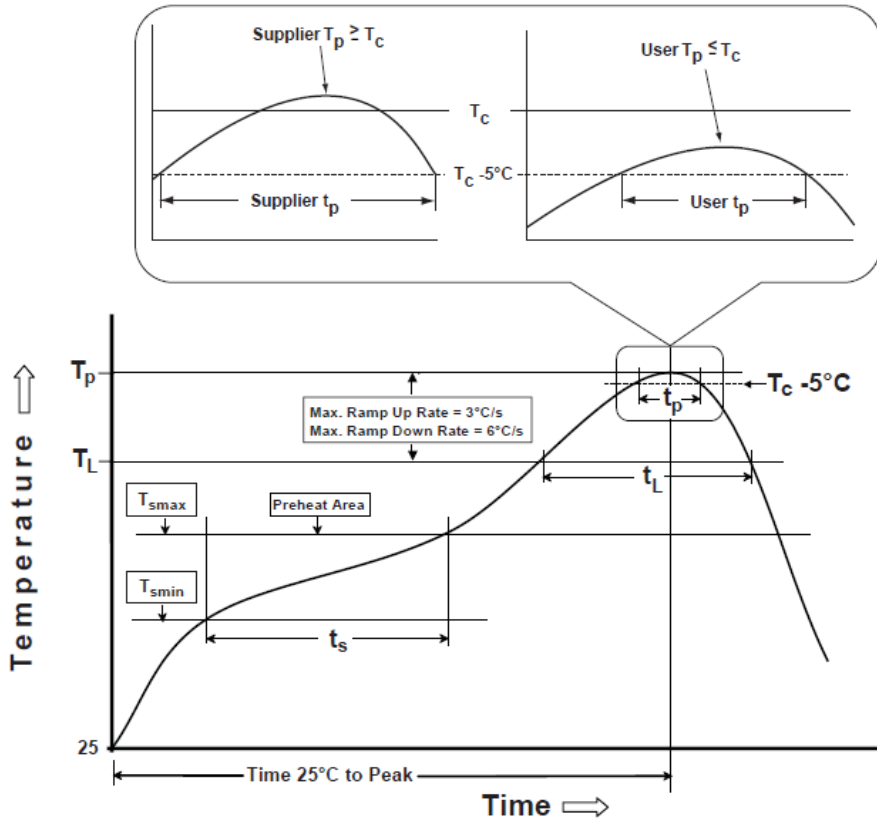

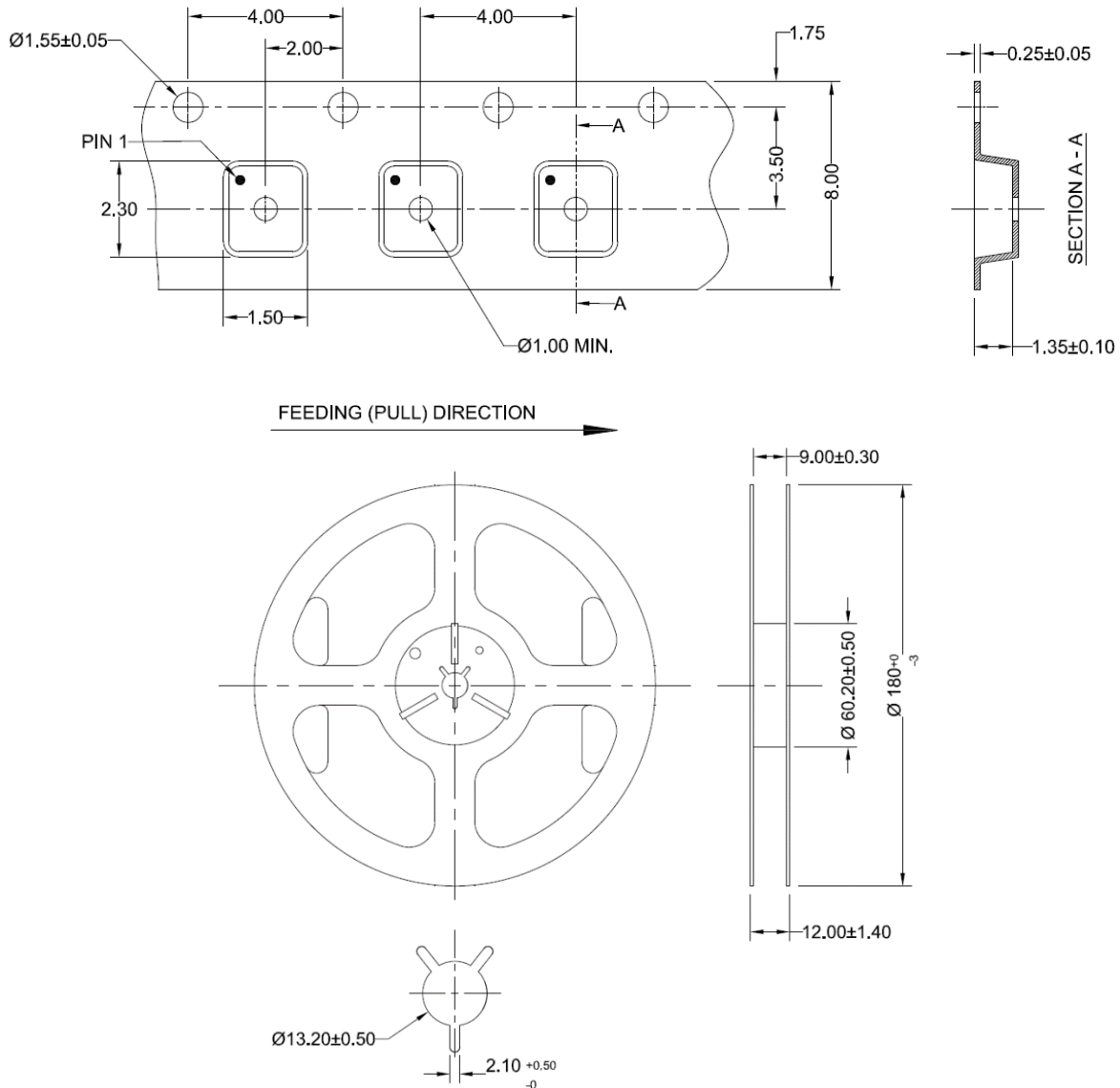
