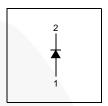

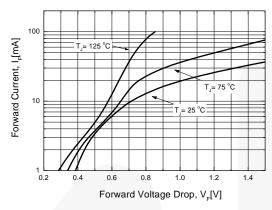
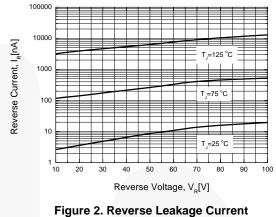


Figure 1. Forward Current Characteristics



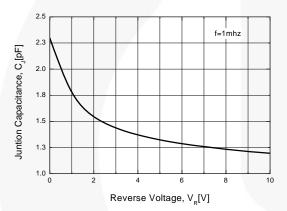


Figure 3. Junction Capacitance

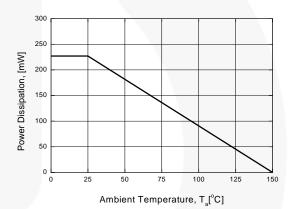
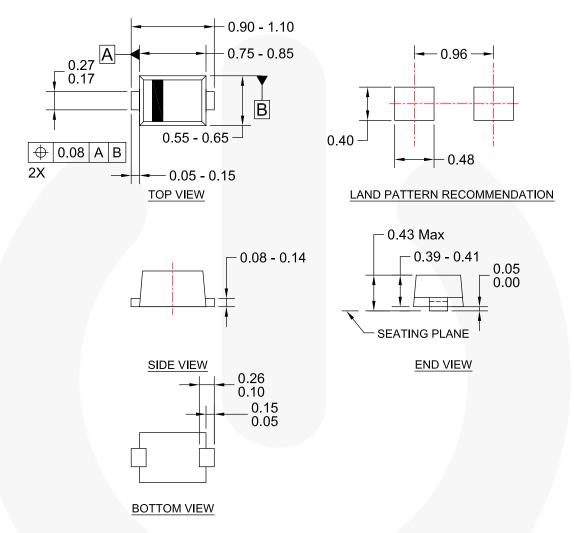


Figure 4. Power Derating
