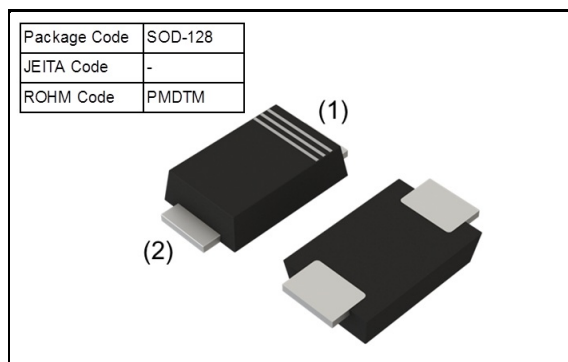

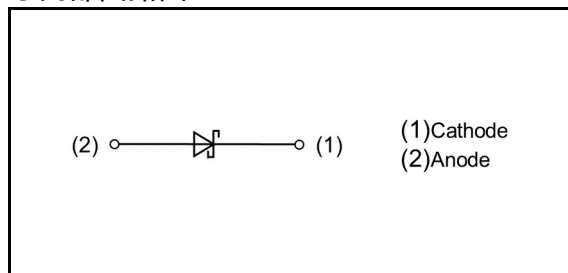
使用上の注意

●外形図



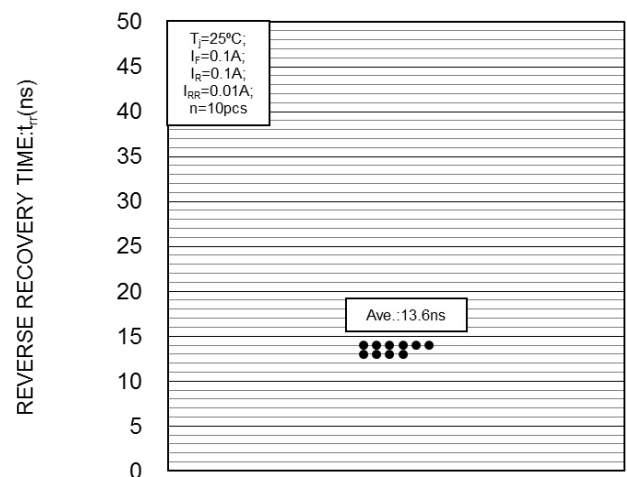
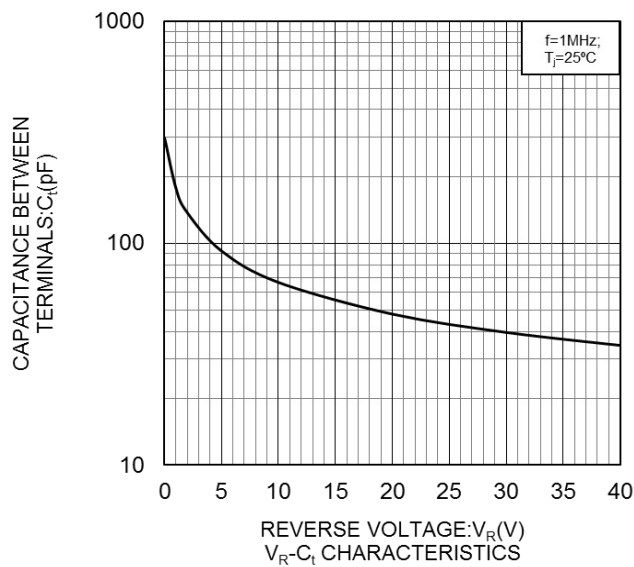
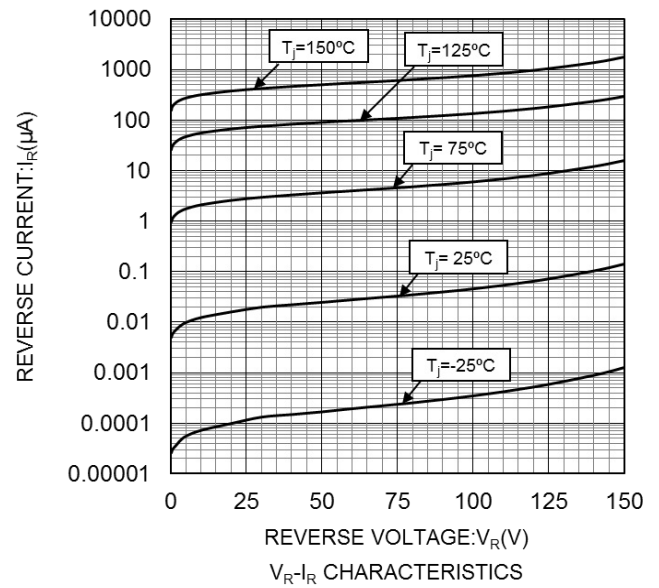
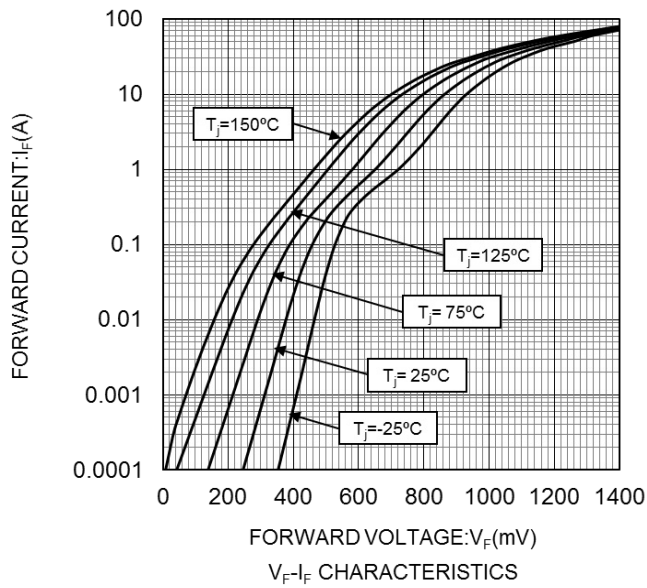
