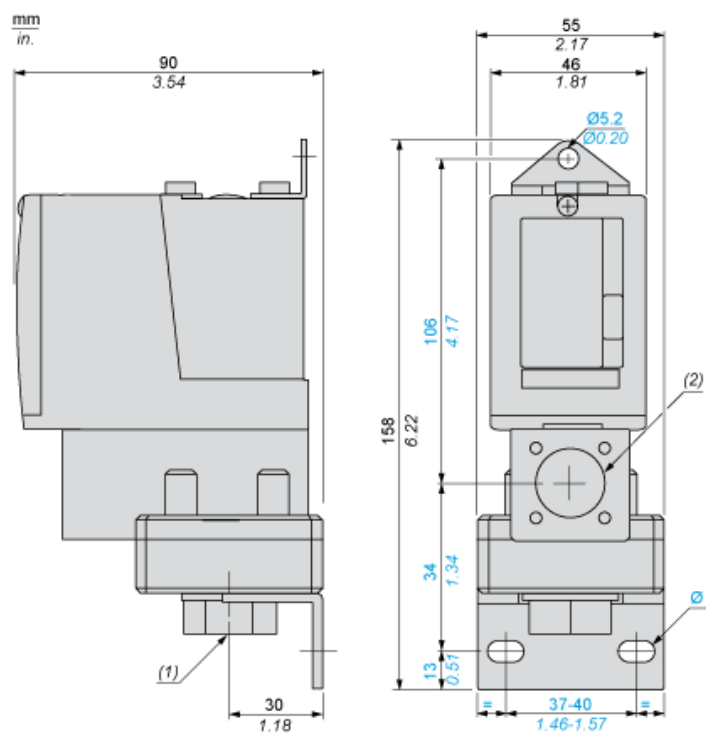

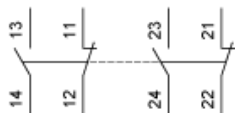

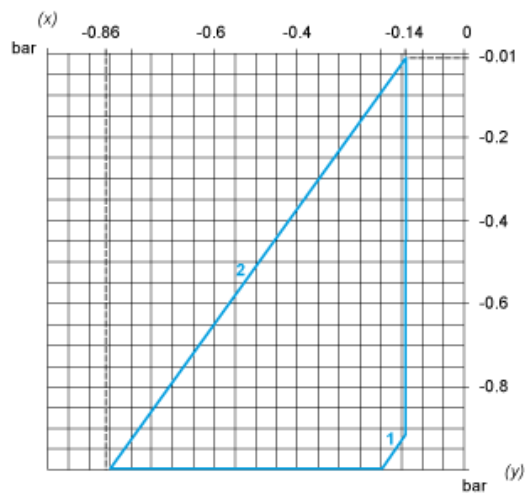
- (1) 1 fluid entry, tapped G1/4 (BSP female)

Wiring Diagram

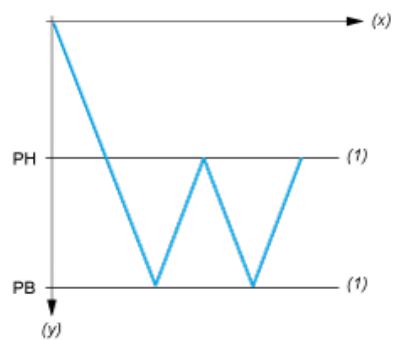
Terminal Model
