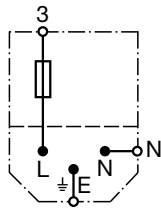


Snap-in mounting type KEA-PRINT

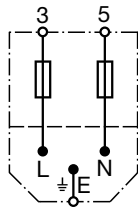

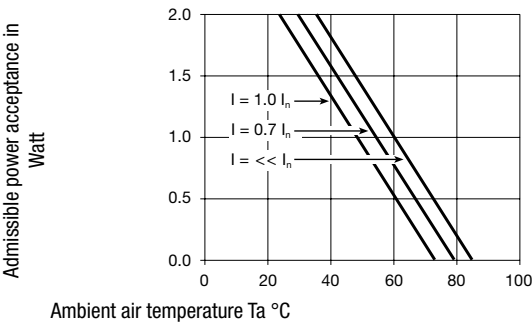


with internal connections

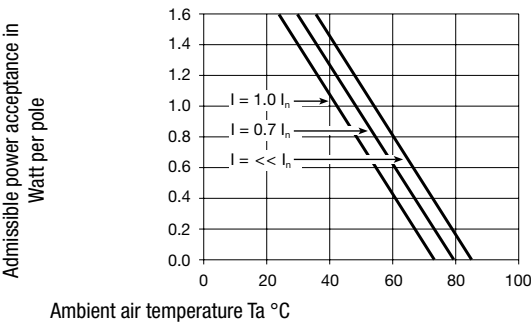


Derating Curves
