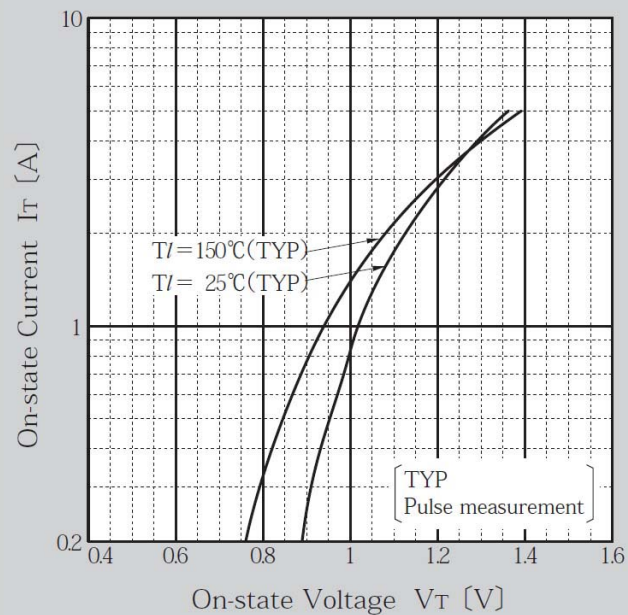

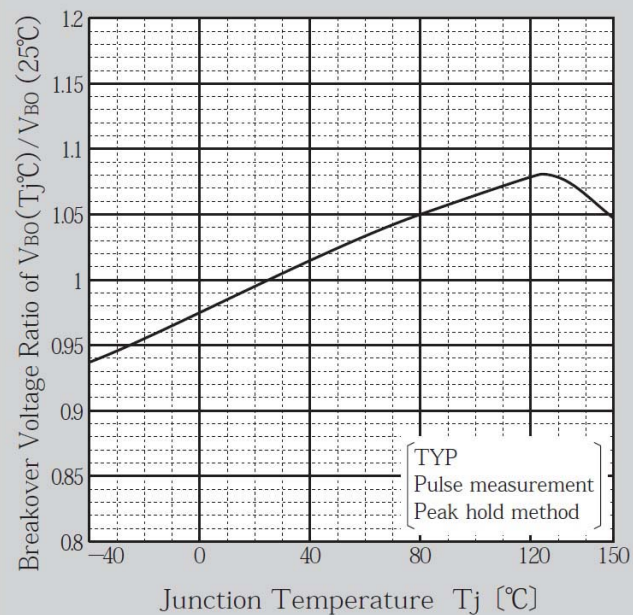

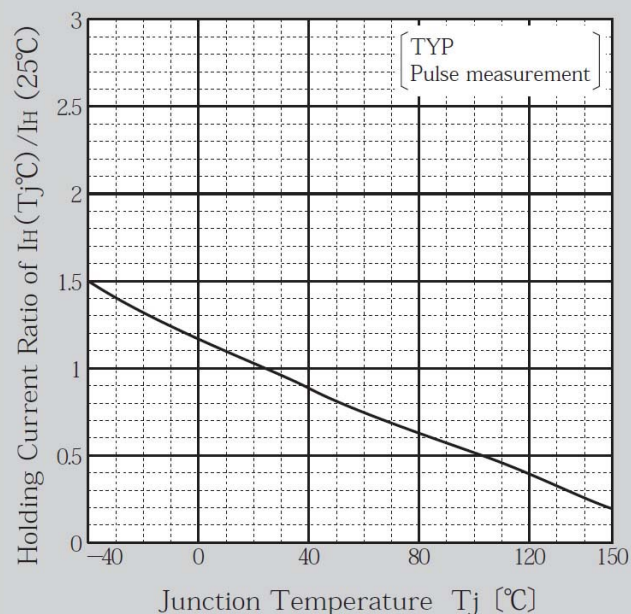
On-state Voltage vs On-state Current



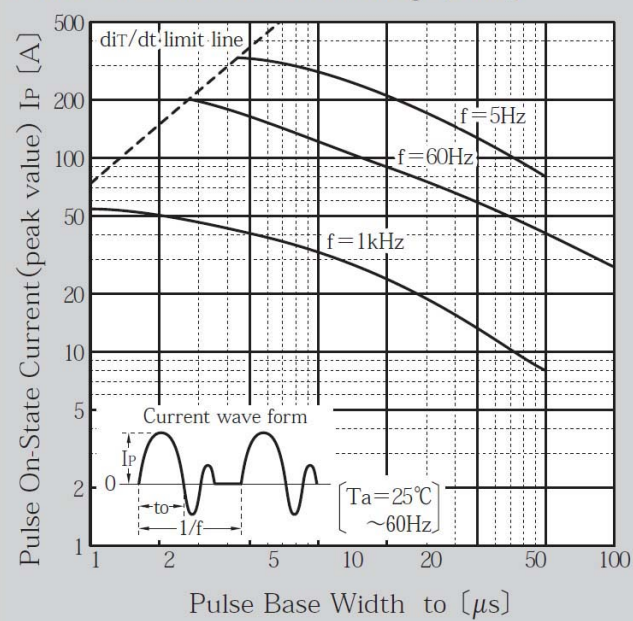
Breakover Voltage vs Junction Temperature



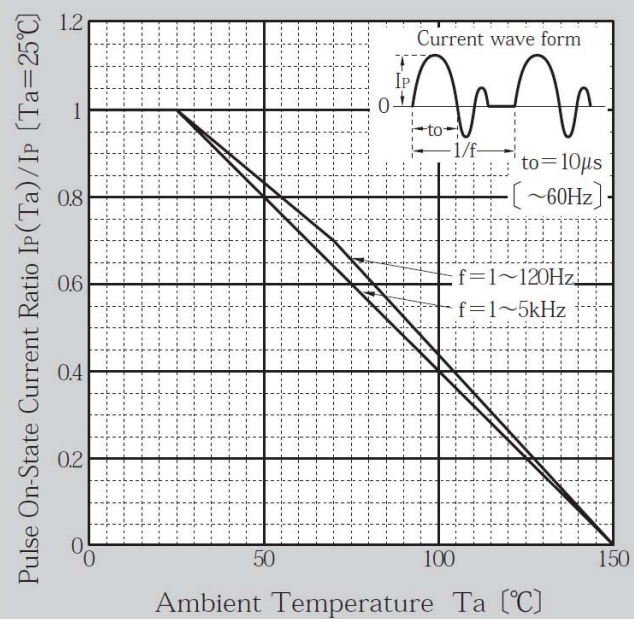
Holding Current vs Junction Temperature



Pulse On-state Current Rating (I_{TRM})

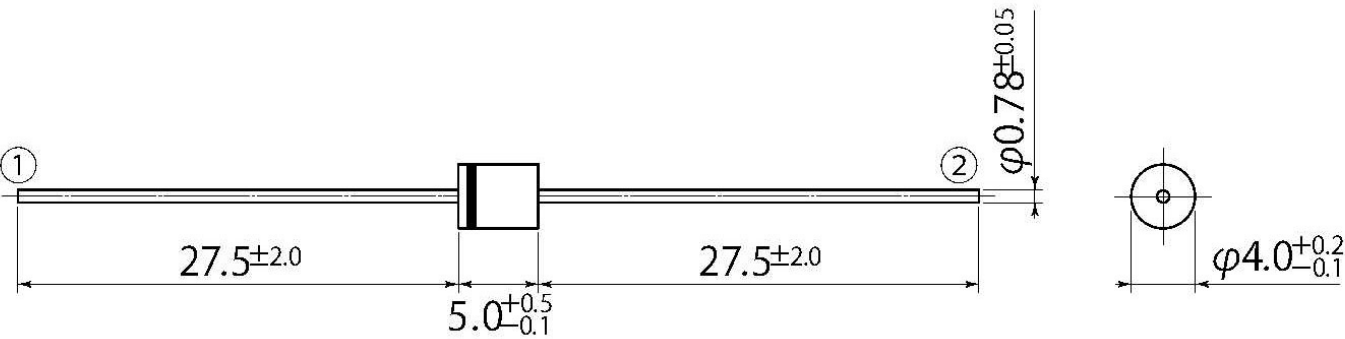


Pulse On-state Current Derating (I_{TRM})
