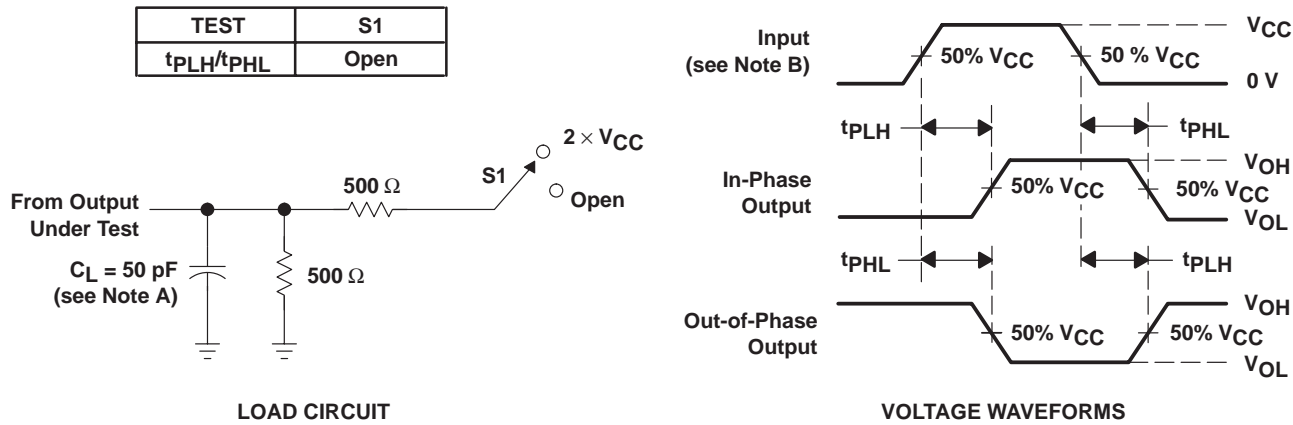

CERAMIC DUAL IN LINE PACKAGE



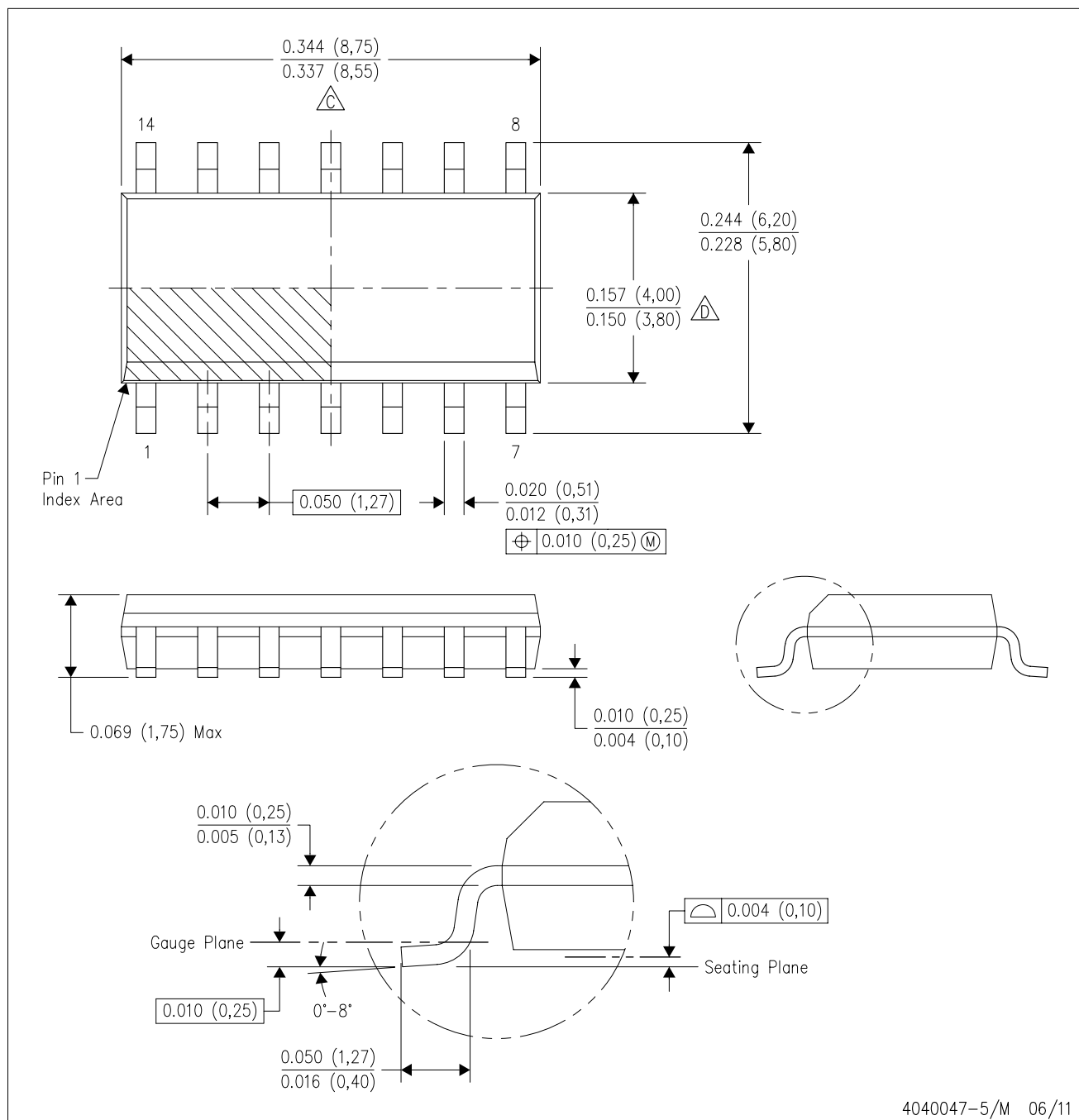
LAND PATTERN EXAMPLE
