







Fig. 8.1 I<sub>C</sub> - V<sub>CE</sub>

Fig. 8.2 h<sub>FE</sub> - I<sub>C</sub>







Fig. 8.3 V<sub>CE(sat)</sub> - I<sub>C</sub>








Fig. 8.5 f<sub>T</sub> - I<sub>C</sub>

Fig. 8.6 I<sub>B</sub> - V<sub>BE</sub>






Fig. 8.7  $\;$  PC -  $T_a$  Reference only with  $T_j$  of 125  $^{\circ} C.$ 


Fig. 8.8  $P_C$  -  $T_a$  Reference only with  $T_j$  of 150  $^{\circ}$ C.
