




Fig. 6.1 Definitions of Electrical Characteristics






Fig. 8.1 Land Pattern Dimensions (Unit: mm)






Fig. 9.1 I - V



10. Clamp Voltage V_C - Peak Pulse Current (I_{PP}) (Note)






Fig. 10.1 V_C - I_{PP}





Fig. 11.3 IEC61000-4-2 (Contact)
