




Fig. 6.2.1 Test Circuit of Switching Time

Fig. 6.2.2 Timing Chart of Switching Time




Fig. 6.2.3 Timing Chart of Switching Loss




Fig. 7.1 Marking





Fig. 8.1 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.3 V<sub>CE</sub> - V<sub>GE</sub>





Fig. 8.4 V<sub>CE</sub> - V<sub>GE</sub>






Fig. 8.6 V<sub>CE(sat)</sub> - T<sub>c</sub>





Fig. 8.7  $t_{on}$ ,  $t_{r}$  -  $R_{G}$ 






Fig. 8.9 toff, tf - RG




Fig. 8.10 t<sub>off</sub>, t<sub>f</sub> - I<sub>C</sub>




Fig. 8.11 Eon, Eoff - RG




Fig. 8.12 Eon, Eoff - IC




Fig. 8.13 V<sub>CE</sub>, V<sub>GE</sub> - Q<sub>g</sub>




Fig. 8.14 I<sub>F</sub> - V<sub>F</sub>




Fig. 8.15 I<sub>rr</sub>, t<sub>rr</sub> - I<sub>F</sub>




Fig. 8.16 Safe Operating Area (Guaranteed Maximum)





Fig. 8.17 Reverse Bias SOA (Guaranteed Maximum)


