






Fig. 8.1 Marking RN1112





Fig. 8.2 Marking RN1113




Fig. 9.1 RN1112 I_C-V_{I(ON)}




Fig. 9.2 RN1113 I_C-V_{I(ON)}





Fig. 9.3 RN1112 I_C-V_{I(OFF)}




Fig. 9.5 RN1112 h_{FE}-I_C

Fig. 9.6 RN1113 h_{FE}-I_C






Fig. 9.7 RN1112 V_{CE(sat)}-I_C


Fig. 9.8 RN1113 V_{CE(sat)}-I_C
