






Fig. 8.1 Marking RN1312




Fig. 8.2 Marking RN1313




Fig. 9.5 RN1312 h<sub>FE</sub>-I<sub>C</sub>




Fig. 9.7 RN1312 V<sub>CE(sat)</sub>-I<sub>C</sub>

Fig. 9.8 RN1313 V<sub>CE(sat)</sub>-I<sub>C</sub>





Fig. 9.9 RN1312,RN1313 P<sub>C</sub>-T<sub>a</sub>
