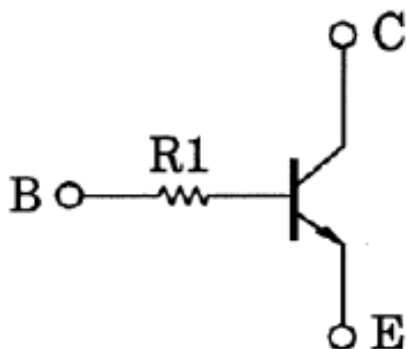

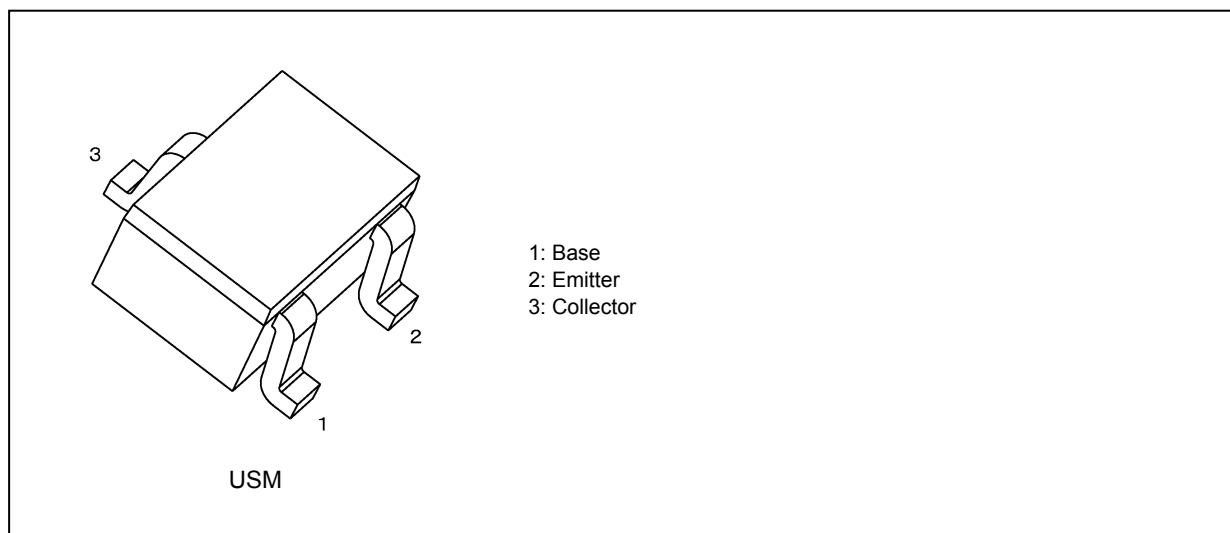

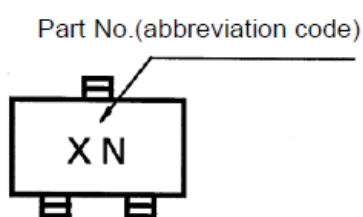


Fig. 8.1 Marking RN1312

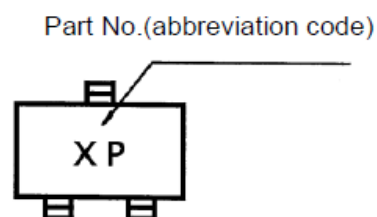


Fig. 8.2 Marking RN1313

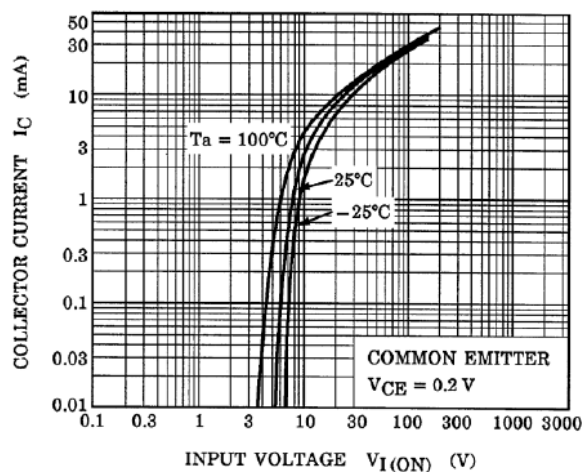


Fig. 9.1 RN1312  $I_C$ - $V_{I(ON)}$

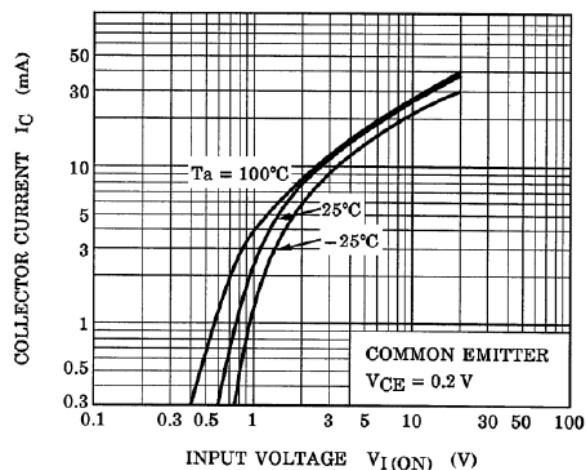


Fig. 9.2 RN1313  $I_C$ - $V_{I(ON)}$

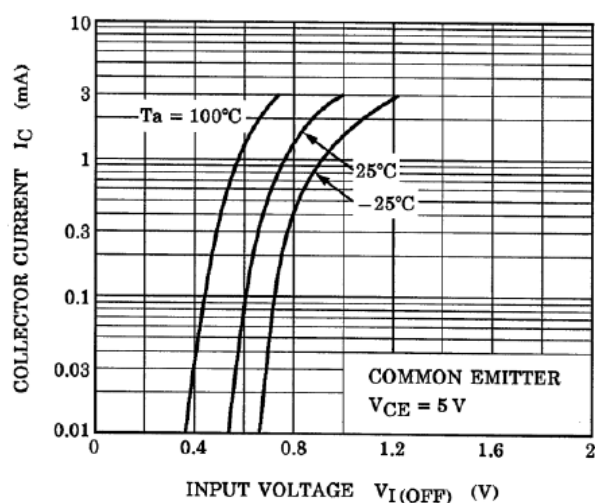


Fig. 9.3 RN1312  $I_C$ - $V_{I(OFF)}$

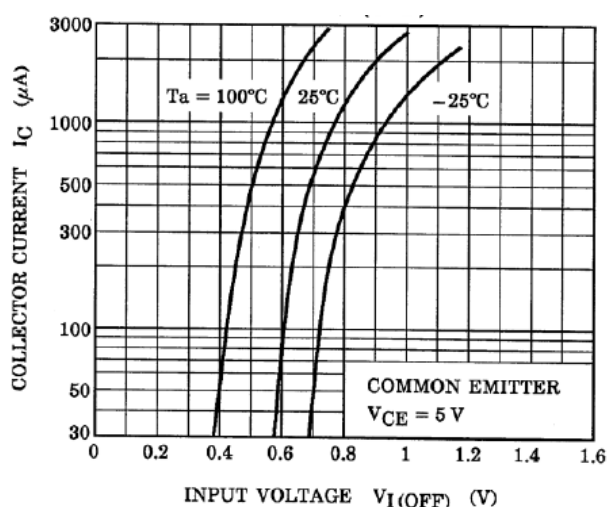


Fig. 9.4 RN1313  $I_C$ - $V_{I(OFF)}$

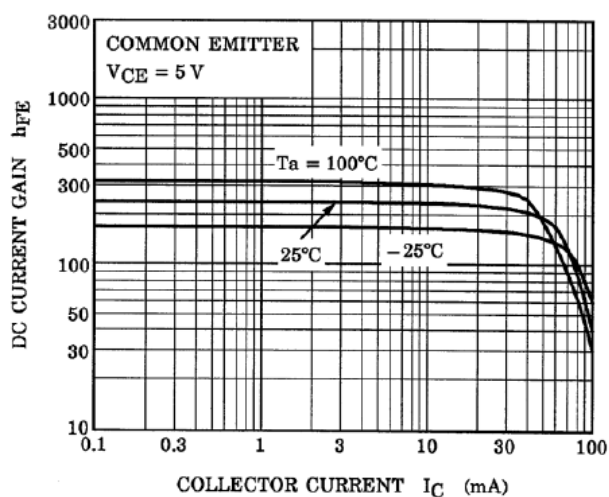


Fig. 9.5 RN1312  $h_{FE}$ - $I_C$

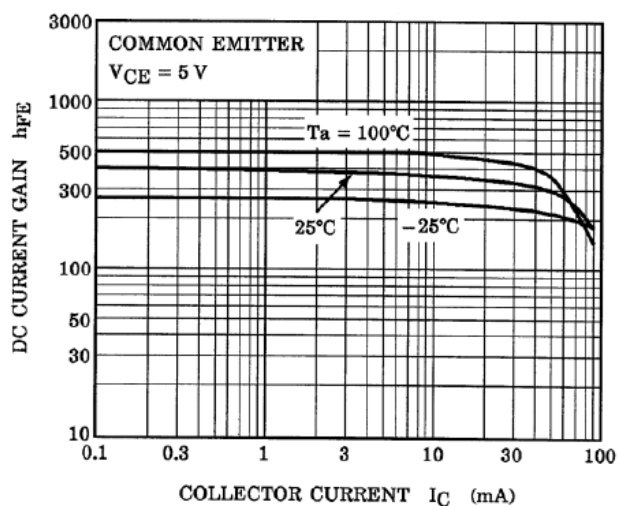


Fig. 9.6 RN1313  $h_{FE}$ - $I_C$

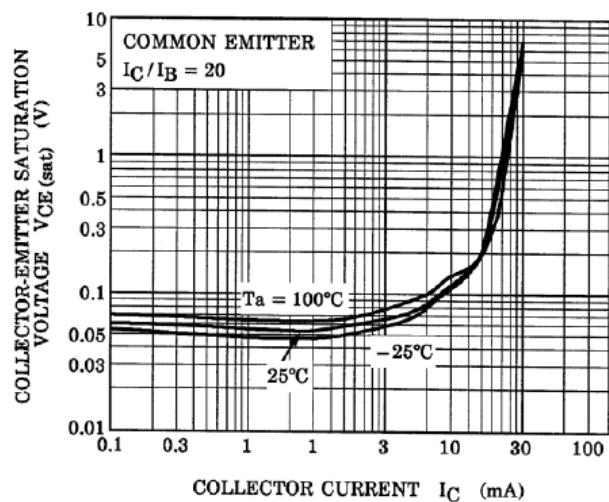


Fig. 9.7 RN1312  $V_{CE(sat)}$ - $I_C$

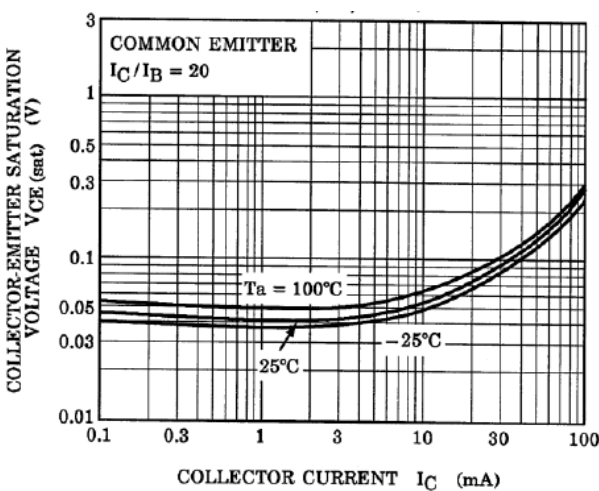


Fig. 9.8 RN1313  $V_{CE(sat)}$ - $I_C$

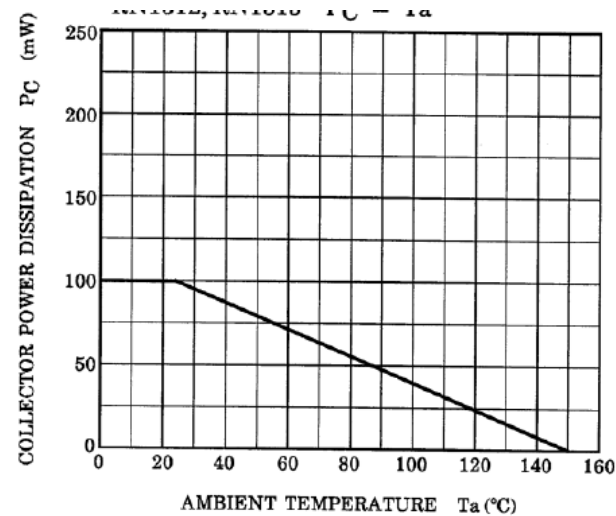
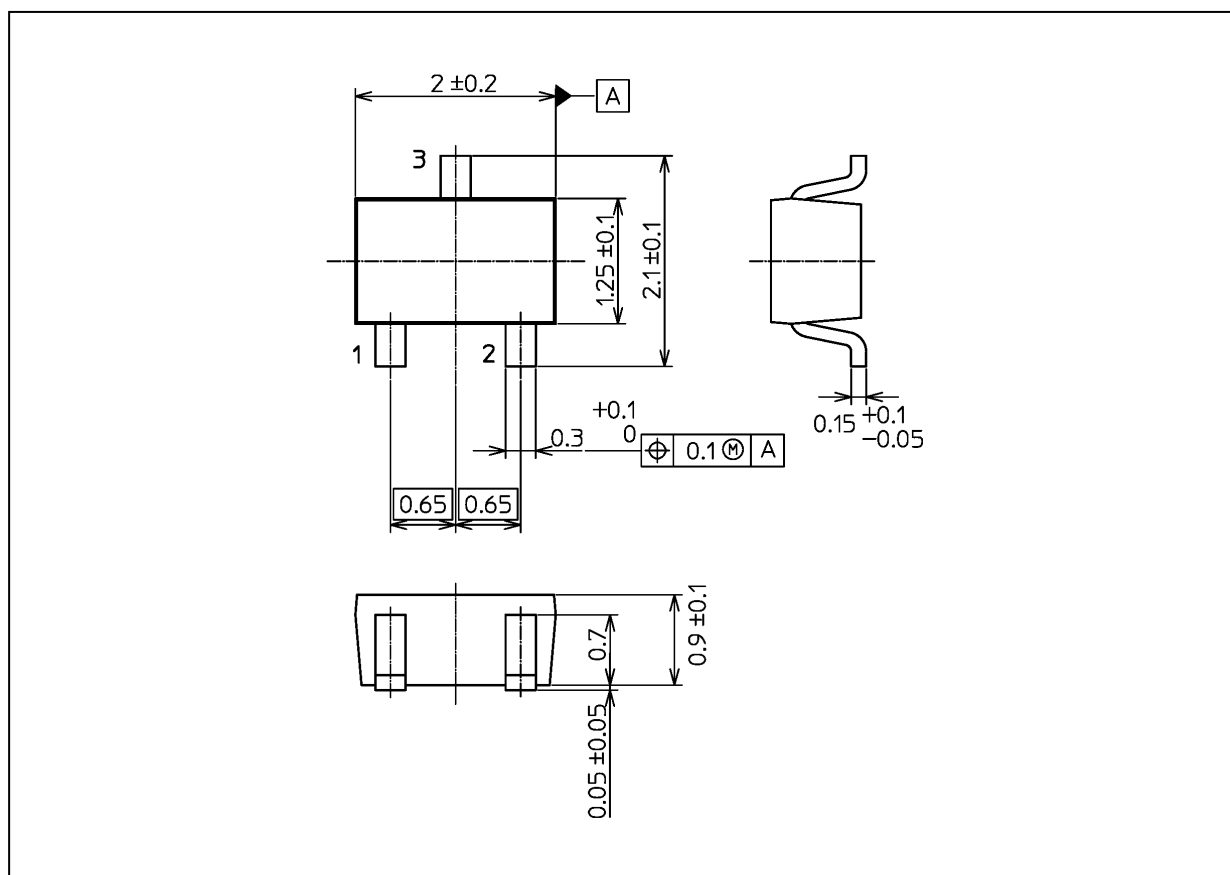


Fig. 9.9 RN1312,RN1313  $P_C$ - $T_a$
