






Fig. 9.1 Marking RN2107




Fig. 9.3 Marking RN2109




Fig. 9.2 Marking RN2108




Fig. 10.1 RN2107 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 10.3 RN2109 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 10.5 RN2108 I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 10.2 RN2108 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 10.4 RN2107 I<sub>C</sub>-V<sub>I(OFF)</sub>





Fig. 10.6 RN2109  $I_C$ - $V_{I(OFF)}$ 




