






Fig. 8.1 Marking RN2112




Fig. 8.2 Marking RN2113




Fig. 9.1 RN2112 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 9.2 RN2113 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 9.3 RN2112 I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 9.4 RN2113 I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 9.5 RN2112 h<sub>FE</sub>-I<sub>C</sub>




Fig. 9.6 RN2113 h<sub>FE</sub>-I<sub>C</sub>






Fig. 9.7 RN2112 V<sub>CE(sat)</sub>-I<sub>C</sub>


Fig. 9.8 RN2113 V<sub>CE(sat)</sub>-I<sub>C</sub>
