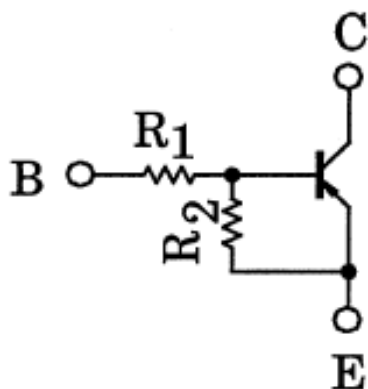

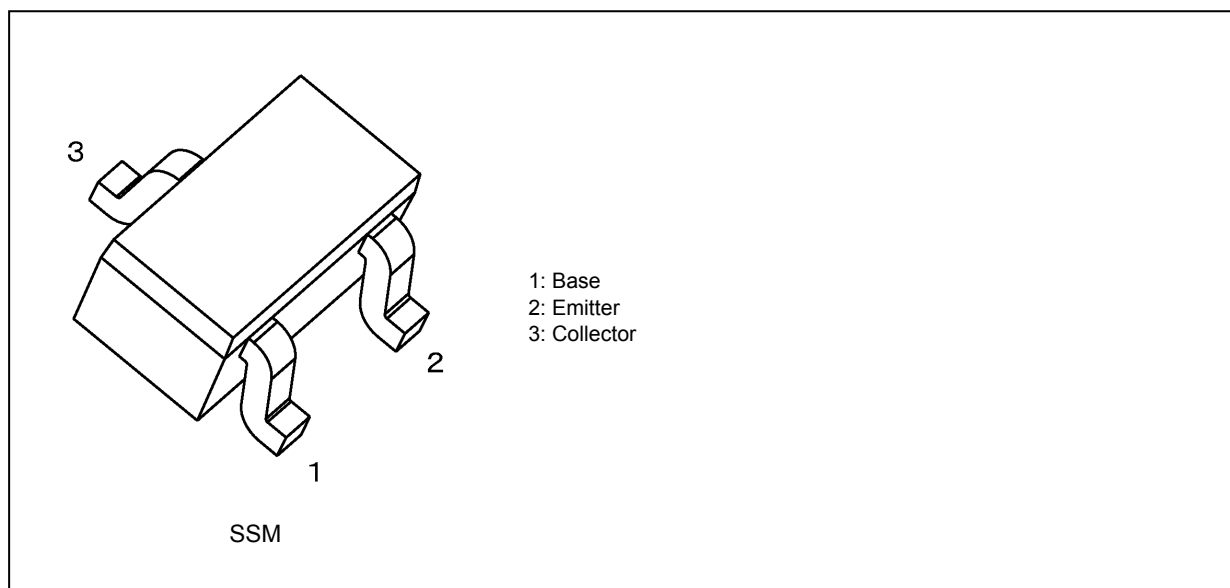

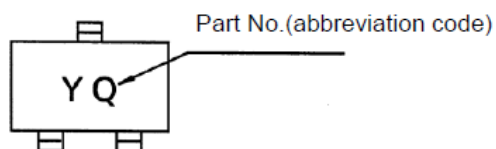


Fig. 9.1 Marking RN2114

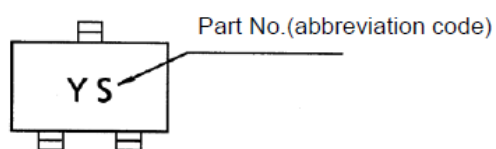


Fig. 9.2 Marking RN2115

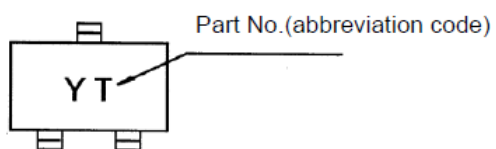


Fig. 9.3 Marking RN2116

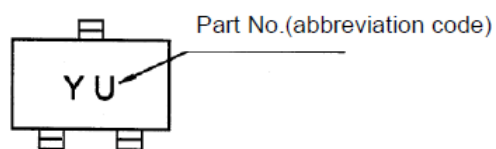


Fig. 9.4 Marking RN2117

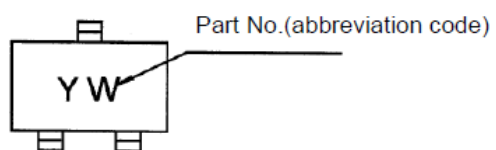


Fig. 9.5 Marking RN2118

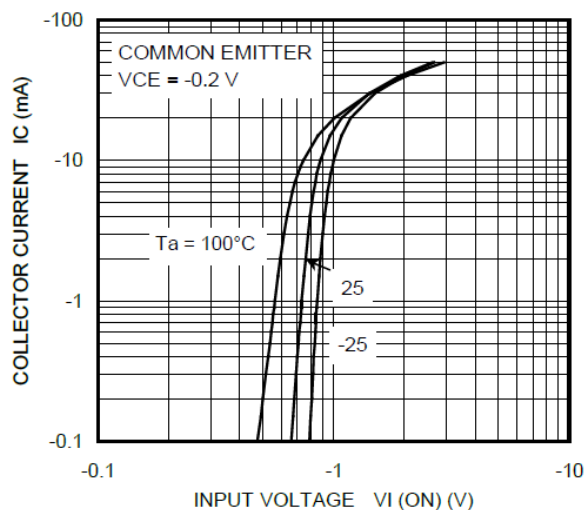


Fig. 10.1 RN2114  $I_C$ - $V_{I(ON)}$

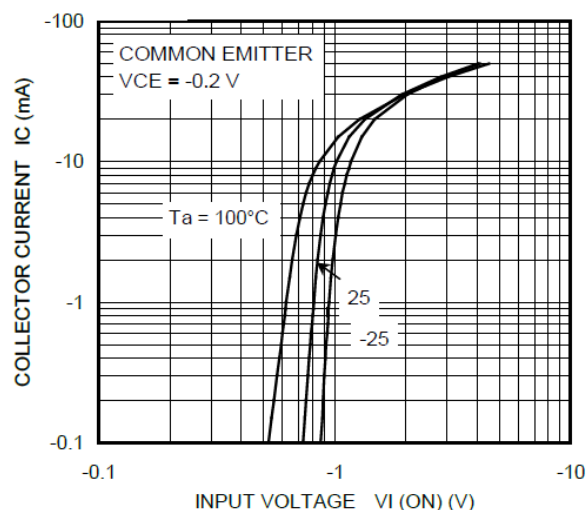


Fig. 10.2 RN2115  $I_C$ - $V_{I(ON)}$

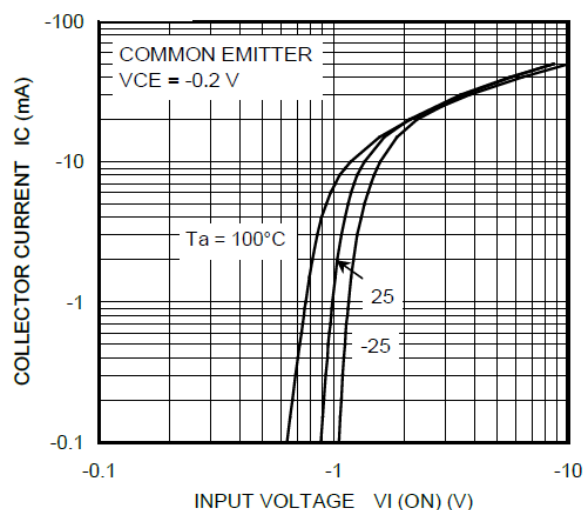


Fig. 10.3 RN2116  $I_C$ - $V_{I(ON)}$

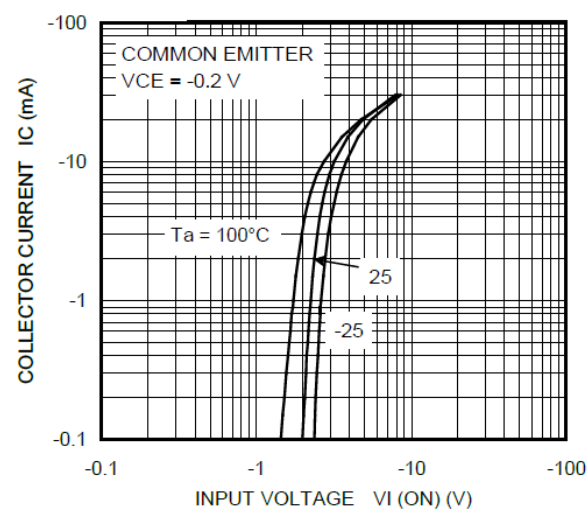


Fig. 10.4 RN2117  $I_C$ - $V_{I(ON)}$

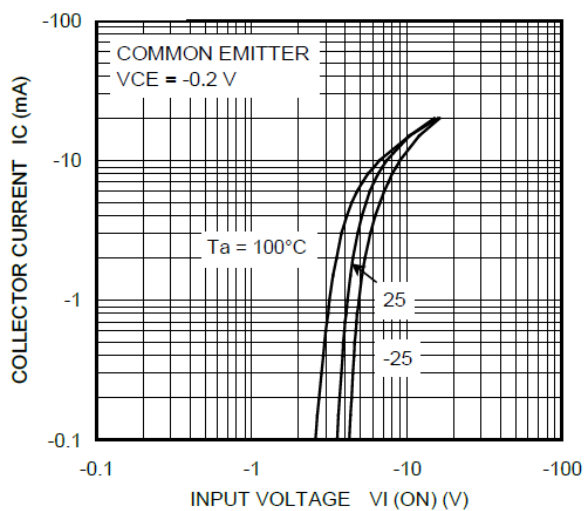


Fig. 10.5 RN2118  $I_C$ - $V_{I(ON)}$

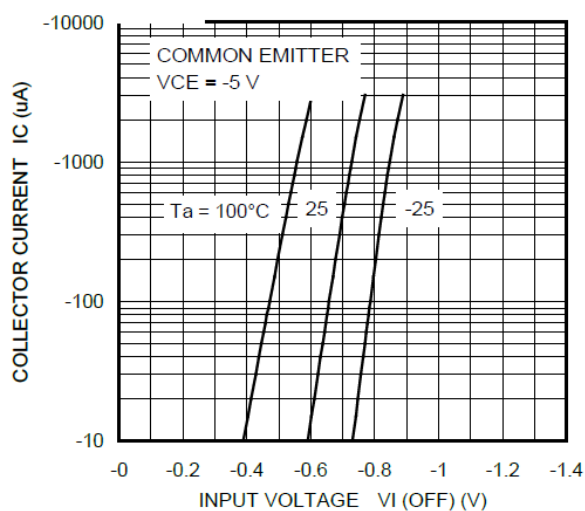


Fig. 10.6 RN2114  $I_C$ - $V_{I(OFF)}$

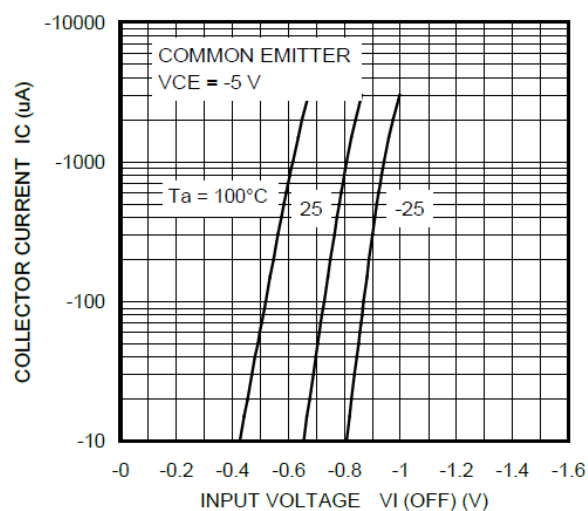


Fig. 10.7 RN2115  $I_C$ - $V_{I(OFF)}$

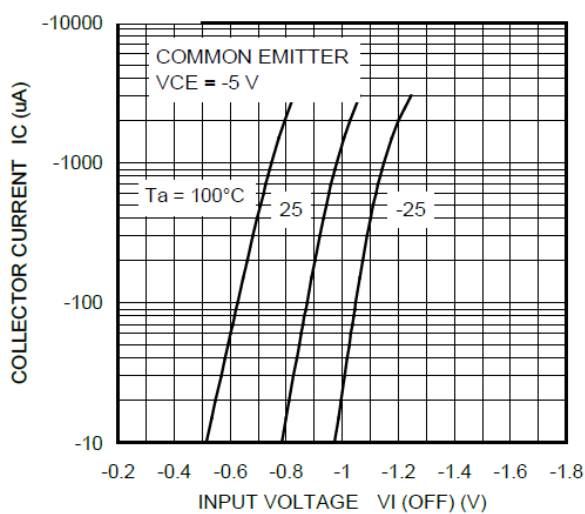


Fig. 10.8 RN2116  $I_C$ - $V_{I(OFF)}$

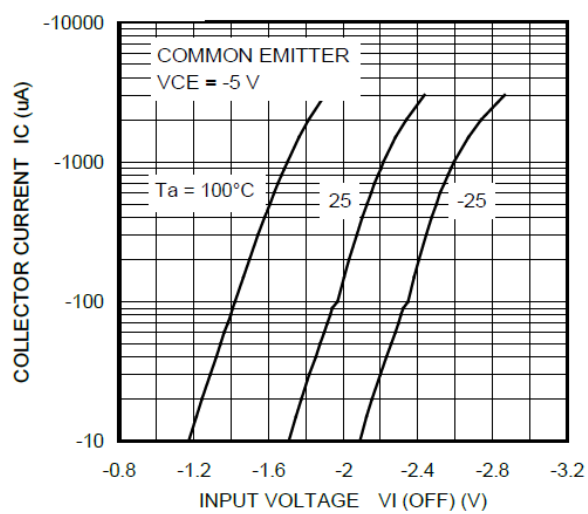


Fig. 10.9 RN2117  $I_C$ - $V_{I(OFF)}$

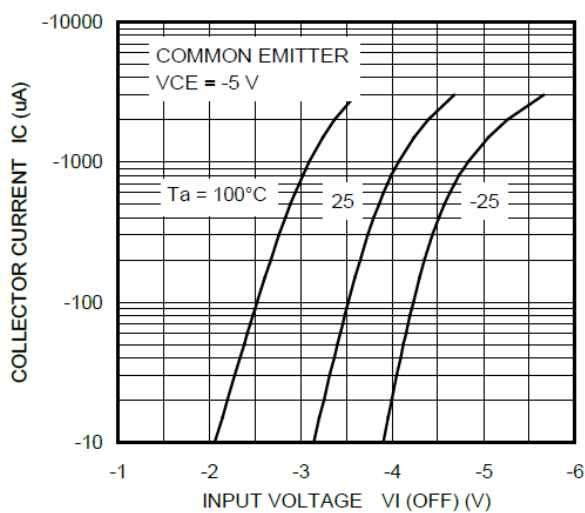


Fig. 10.10 RN2118  $I_C$ - $V_{I(OFF)}$

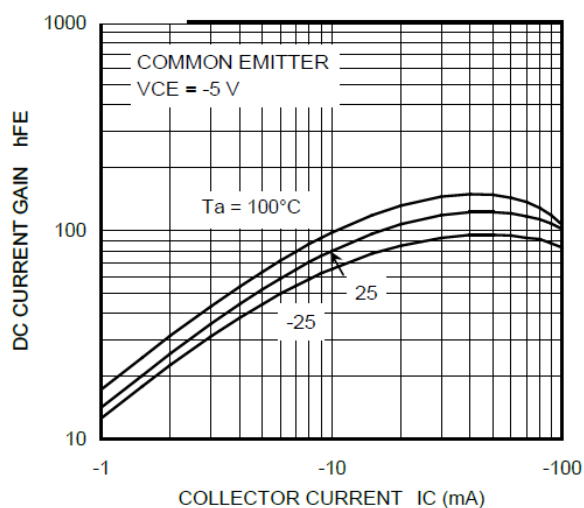


Fig. 10.11 RN2114  $h_{FE}$ - $I_C$

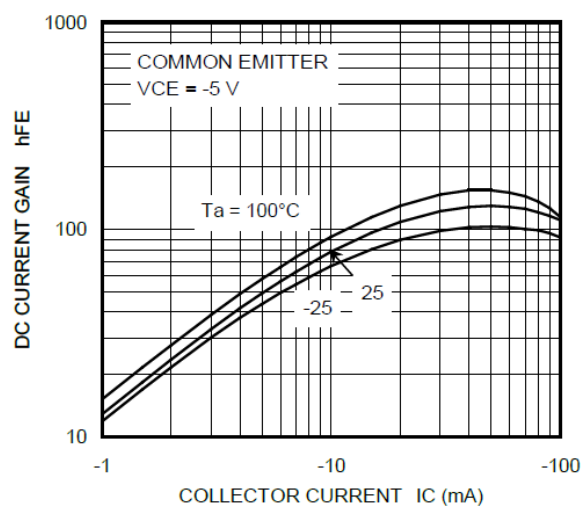


Fig. 10.12 RN2115  $h_{FE}$ - $I_C$

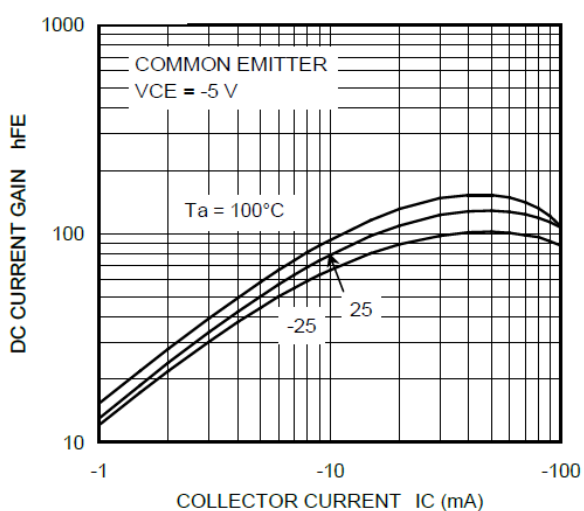


Fig. 10.13 RN2116  $h_{FE}$ - $I_C$

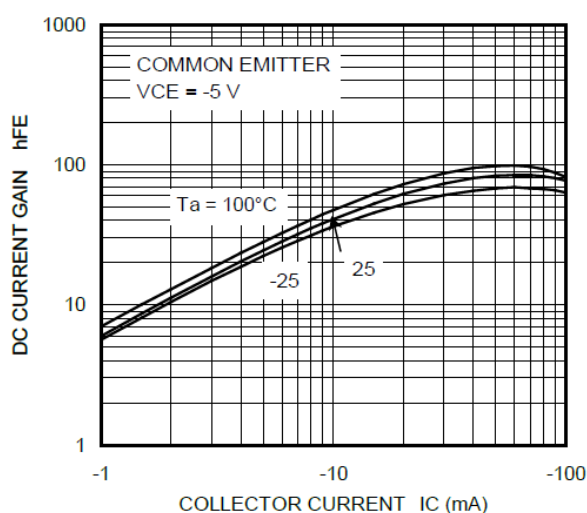


Fig. 10.14 RN2117  $h_{FE}$ - $I_C$

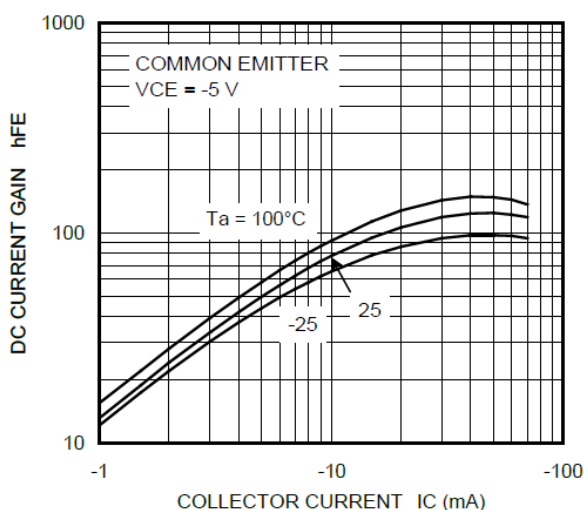


Fig. 10.15 RN2118  $h_{FE}$ - $I_C$



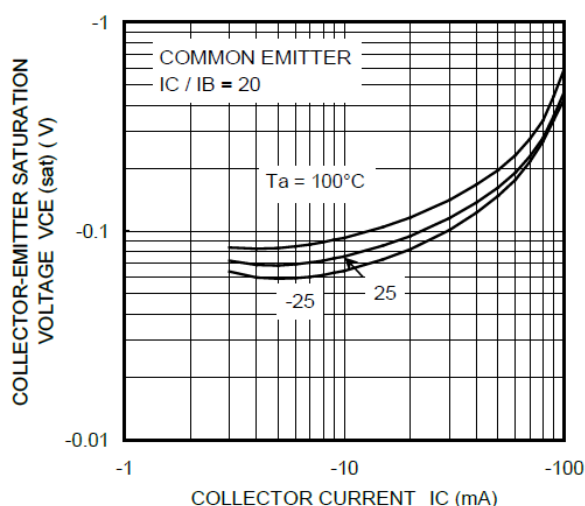


Fig. 10.16 RN2114  $V_{CE(sat)}-I_C$

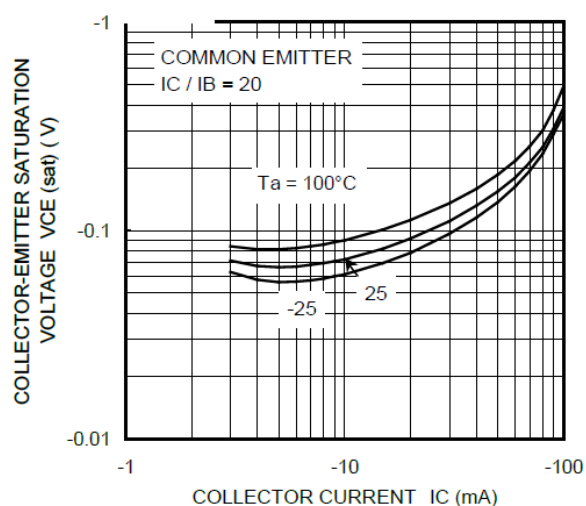


Fig. 10.17 RN2115  $V_{CE(sat)}-I_C$

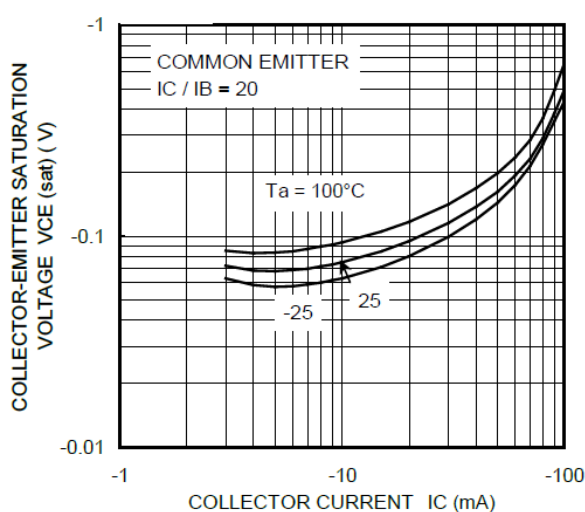


Fig. 10.18 RN2116  $V_{CE(sat)}-I_C$

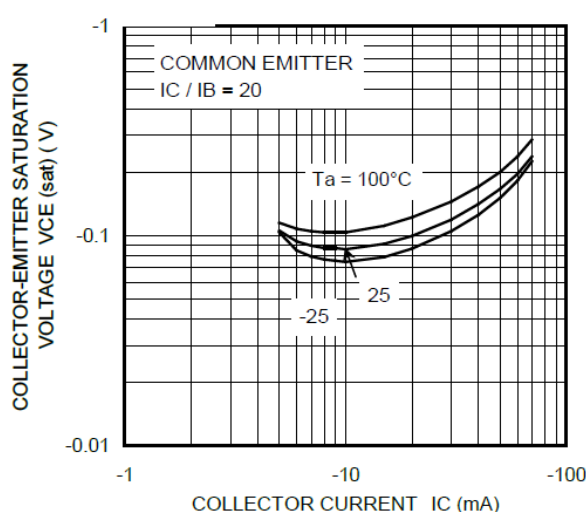


Fig. 10.19 RN2117  $V_{CE(sat)}-I_C$

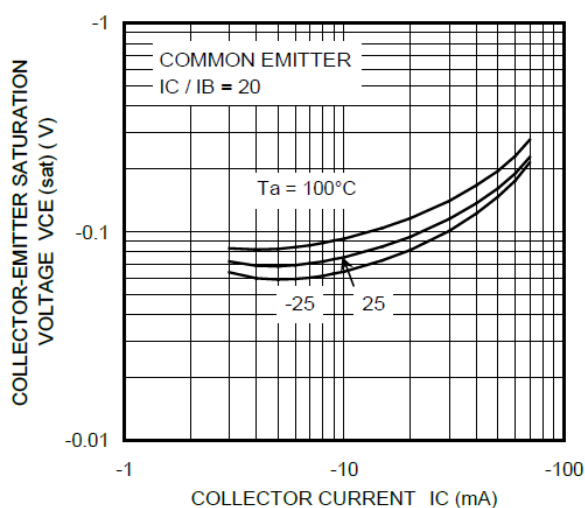
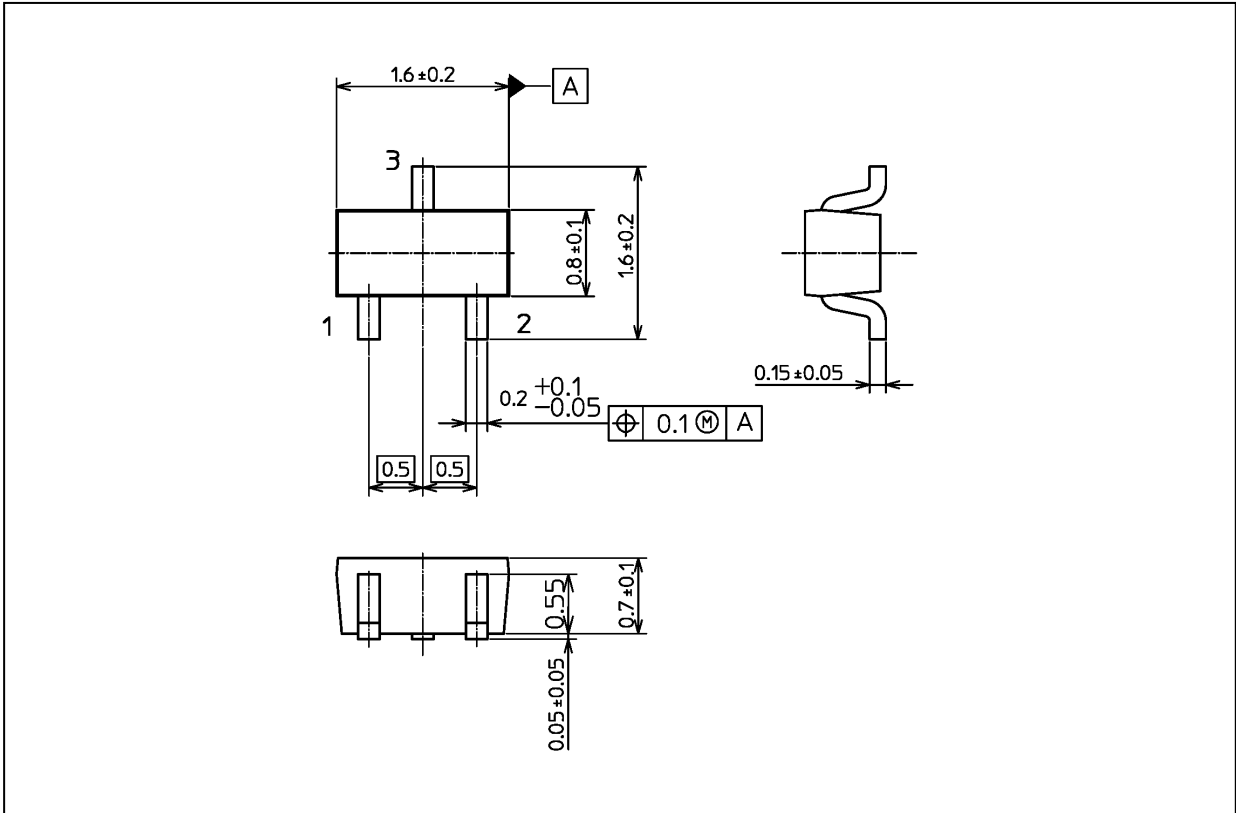


Fig. 10.20 RN2118  $V_{CE(sat)}-I_C$
