






Fig. 8.1 Marking RN2412




Fig. 8.2 Marking RN2413




Fig. 9.1 RN2412 I_C-V_{I(ON)}




Fig. 9.3 RN2412 I_C-V_{I(OFF)}




Fig. 9.5 RN2412 h_{FE}-I_C




Fig. 9.2 RN2413 I_C-V_{I(ON)}




Fig. 9.4 RN2413 I_C-V_{I(OFF)}





Fig. 9.6 RN2413 h_{FE}-I_C








Fig. 9.7 RN2412 V_{CE(sat)}-I_C


Fig. 9.8 RN2413 V_{CE(sat)}-I_C
