




Fig. 9.1 Mraking RN2907




Fig. 9.3 Mraking RN2909



10. Characteristics Curves (Note)(Q1, Q2 Common)







Fig. 10.1 RN2907 I_C-V_{I(ON)}

Fig. 10.2 RN2908 I_C-V_{I(ON)}







Fig. 10.3 RN2909 I_C-V_{I(ON)}

Fig. 10.4 RN2907 I_C-V_{I(OFF)}







Fig. 10.5 RN2908 I_C-V_{I(OFF)}

Fig. 10.6 RN2909 I_C-V_{I(OFF)}




