






Fig. 8.1 Mraking RN2910EF





Fig. 8.2 Mraking RN2911EF

Fig. 9.1 RN2910EF I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 9.2 RN2911EF I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 9.3 RN2910EF I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 9.4 RN2911EF I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 9.5 RN2910EF h<sub>FE</sub>-I<sub>C</sub>

Fig. 9.6 RN2911EF h<sub>FE</sub>-I<sub>C</sub>






Fig. 9.7 RN2910EF V<sub>CE(sat)</sub>-I<sub>C</sub>


Fig. 9.8 RN2911EF V<sub>CE(sat)</sub>-I<sub>C</sub>
