




Fig. 14.1 Q1 I<sub>C</sub>-V<sub>I(ON)</sub> 10000 5000 (VW) 3000 ပ္ Ta = 100°C 25 \_ 25 1000 COLLECTOR CURRENT 500 300 100 50 30 COMMON EMITTER  $V_{CE} = 5 V$ 10 0.2 0.6 1.4 2.2 INPUT VOLTAGE VI(OFF) (V)









Fig. 14.6 Q2 h<sub>FE</sub>-I<sub>C</sub>








Fig. 14.7 Q1 V<sub>CE(sat)</sub>-I<sub>C</sub>


Fig. 14.8 Q2 V<sub>CE(sat)</sub>-I<sub>C</sub>
