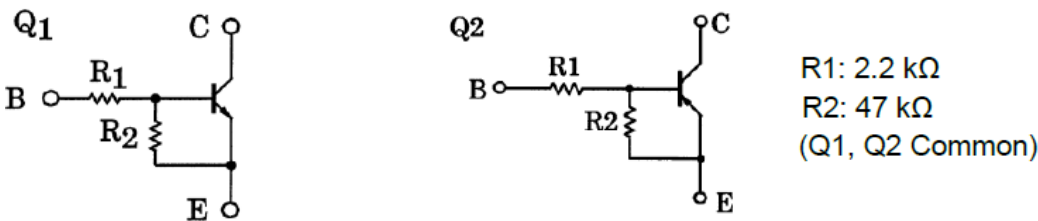

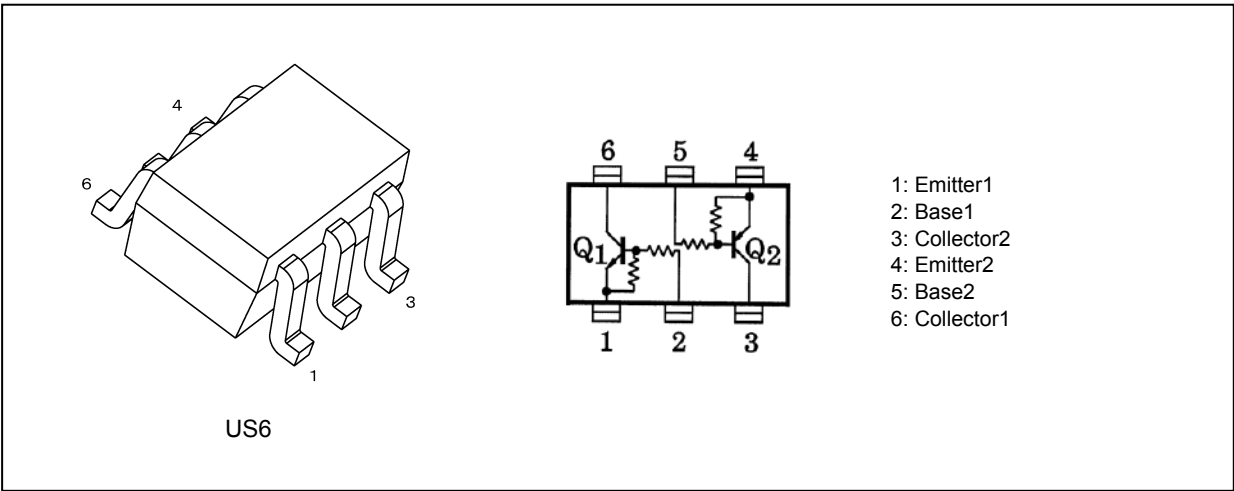

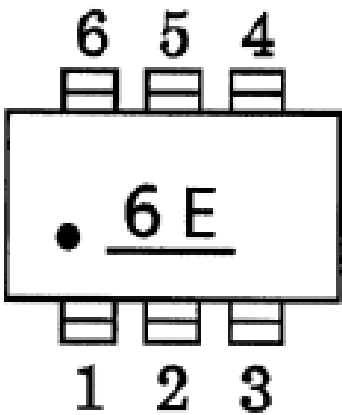

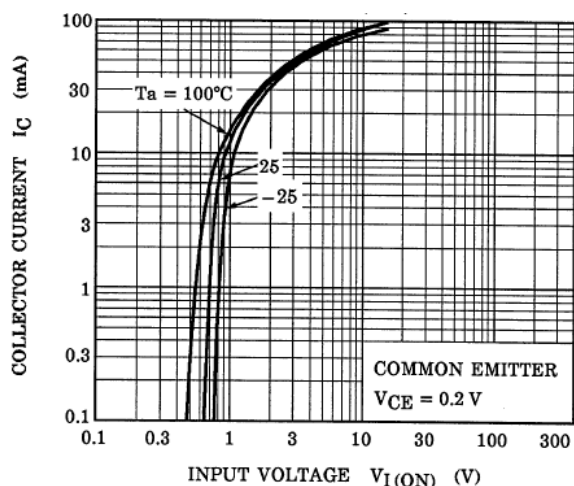


Fig. 13.1 Q1 I_C - $V_{I(ON)}$

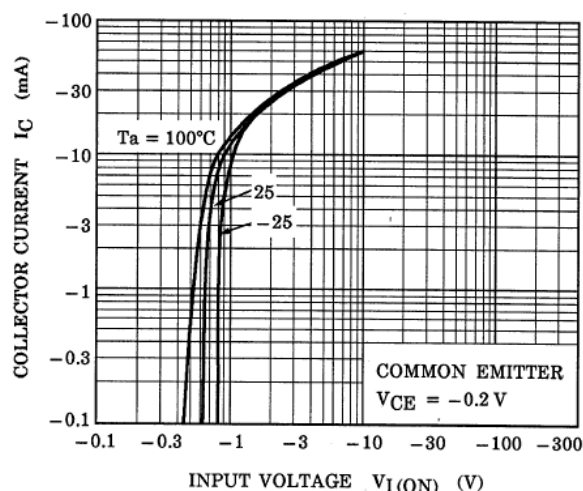


Fig. 13.2 Q2 I_C - $V_{I(ON)}$

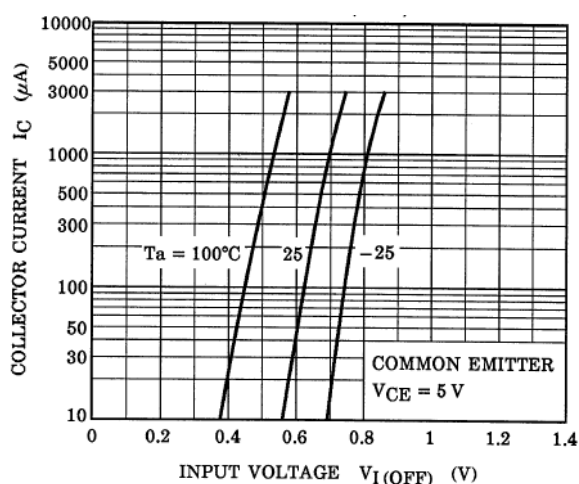


Fig. 13.3 Q1 I_C - $V_{I(OFF)}$

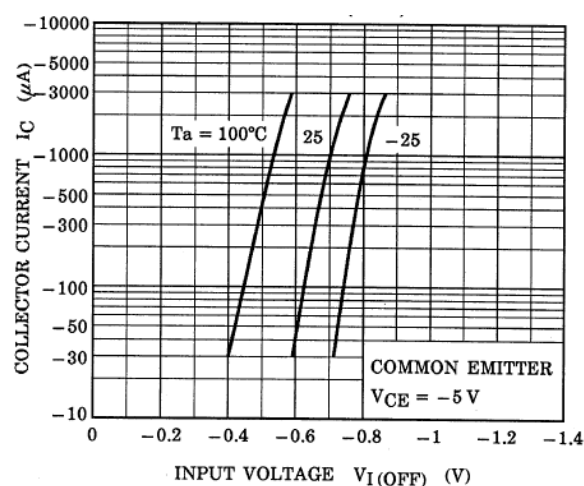


Fig. 13.4 Q2 I_C - $V_{I(OFF)}$

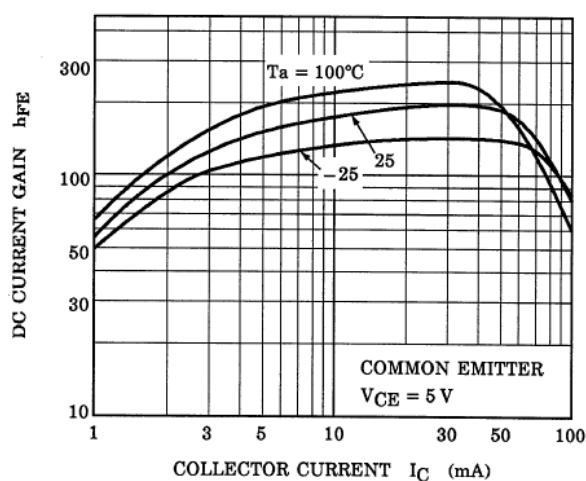


Fig. 13.5 Q1 h_{FE} - I_C

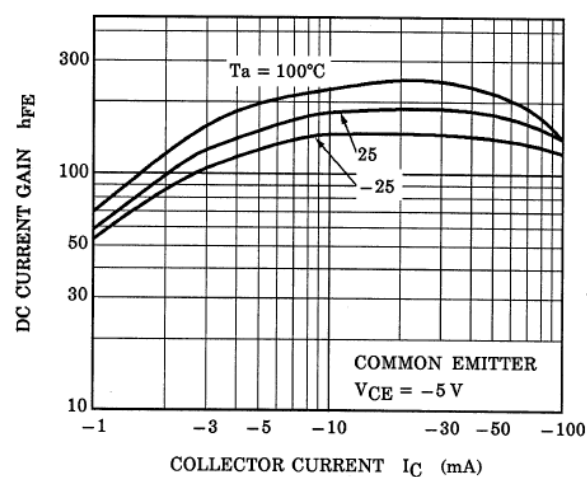


Fig. 13.6 Q2 h_{FE} - I_C

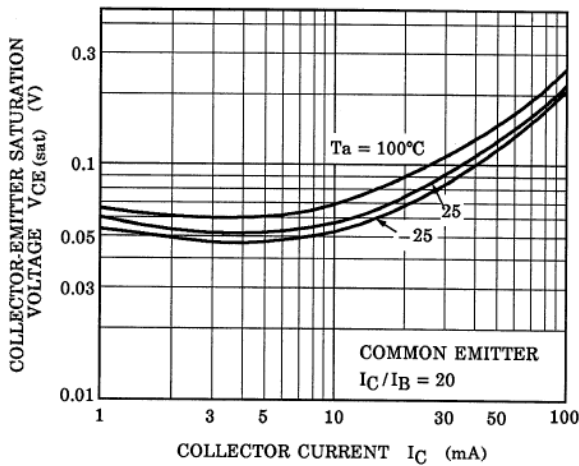


Fig. 13.7 Q1 $V_{CE(sat)}-I_C$

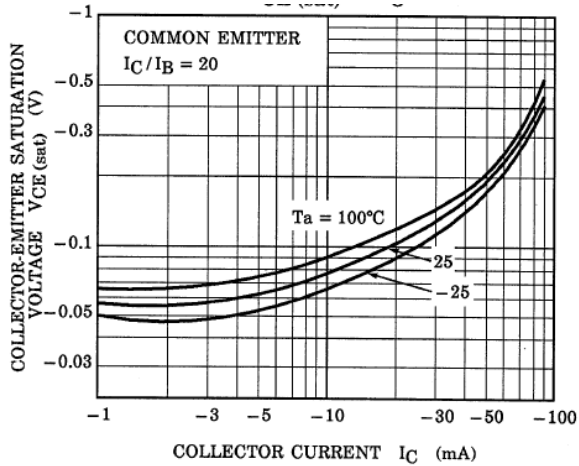
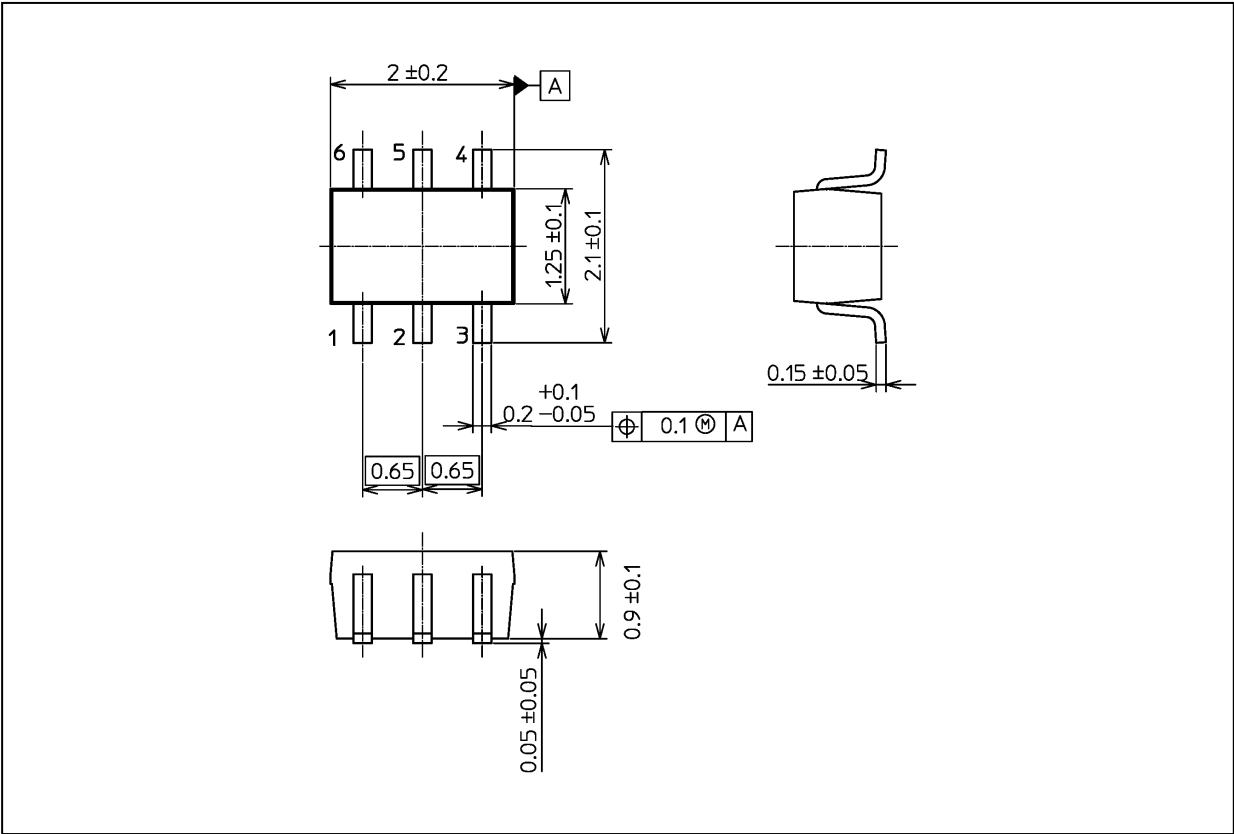


Fig. 13.8 Q2 $V_{CE(sat)}-I_C$
