

Note 1: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (1 mA for this device). 


Fig. 5.3.1 Switching Time Test Circuit




Fig. 5.3.2 Input Waveform/Output Waveform







Fig. 7.12 Dynamic Input Characteristics




