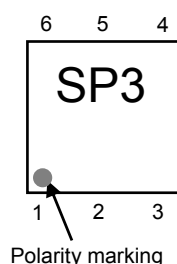

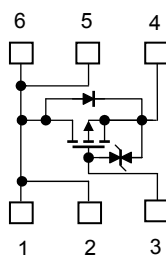

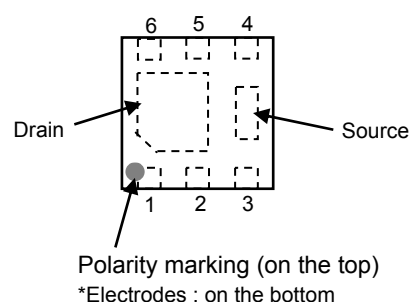
## Marking(Top View)

For normal switching operation, V<sub>GS(on)</sub> requires higher voltage than V<sub>th</sub> and V<sub>GS(off)</sub> requires lower voltage than V<sub>th</sub>. (Relationship can be established as follows: V<sub>GS(off)</sub> < V<sub>th</sub> < V<sub>GS(on)</sub>)

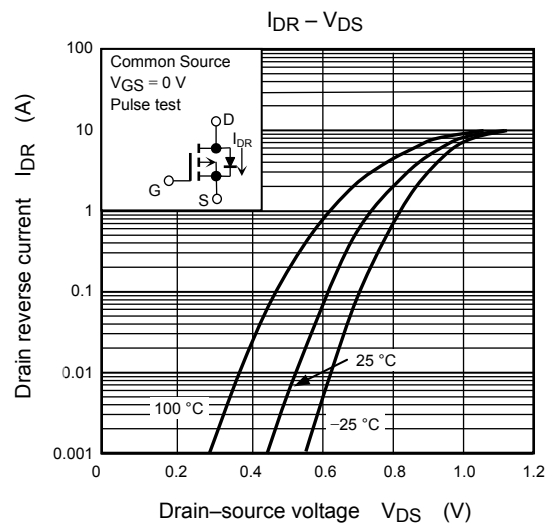
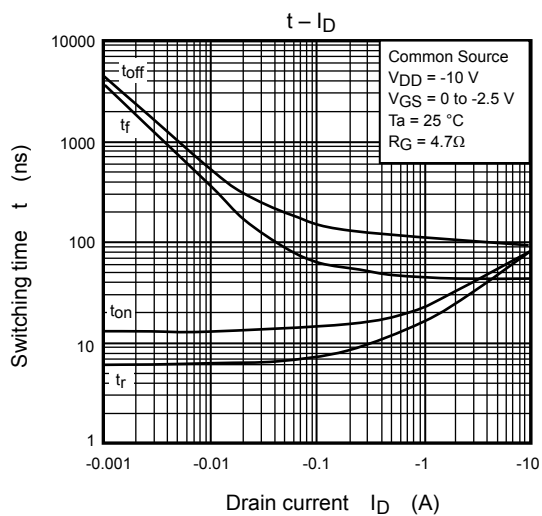
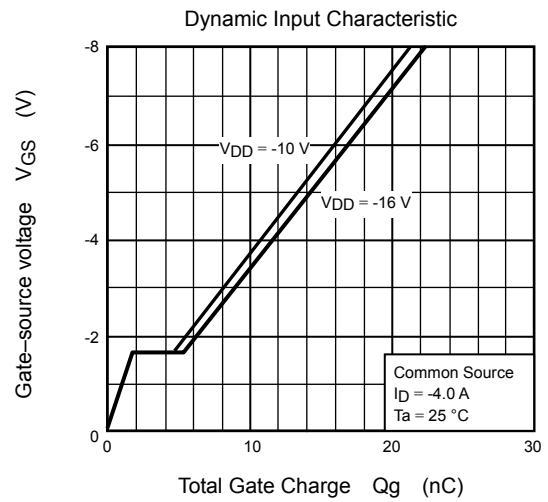
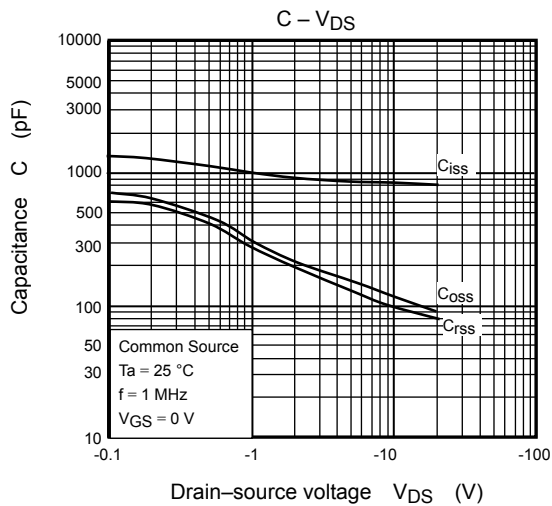
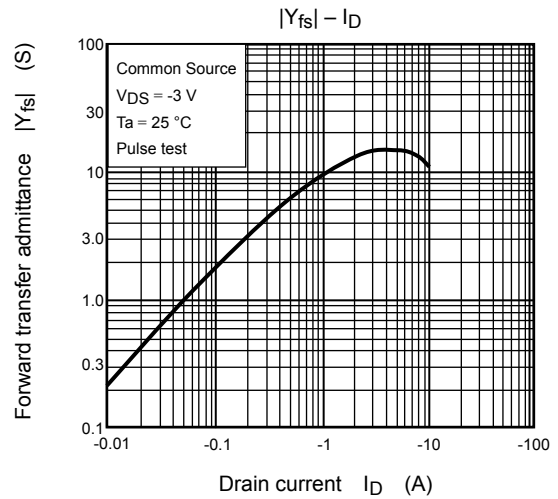
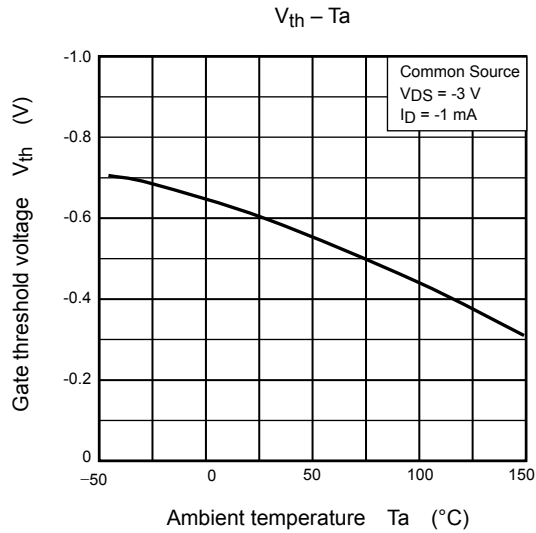

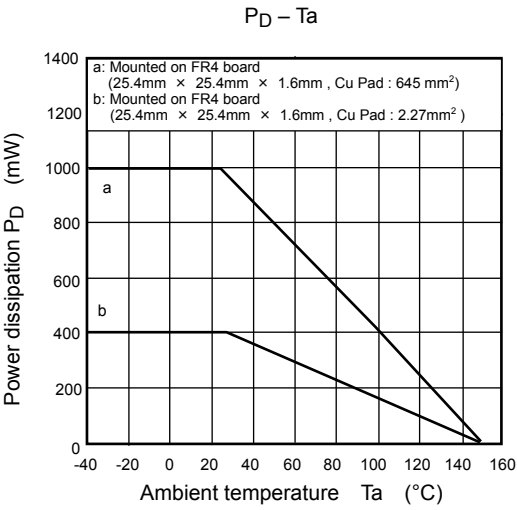
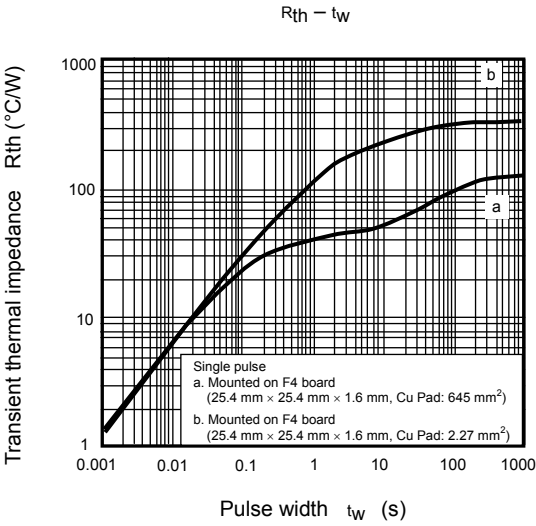
## Handling Precaution
