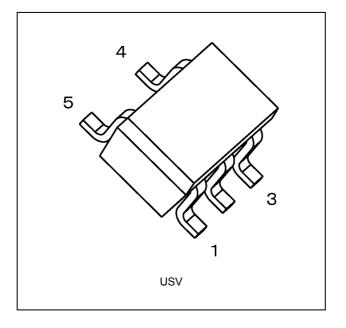

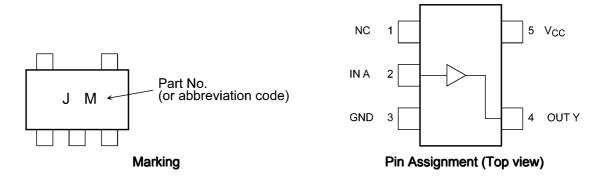

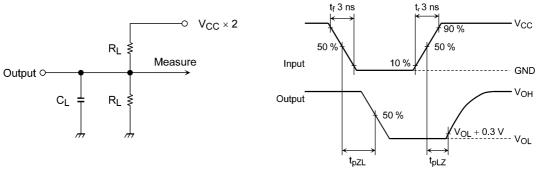

AC Characteristics Measurement Circuit

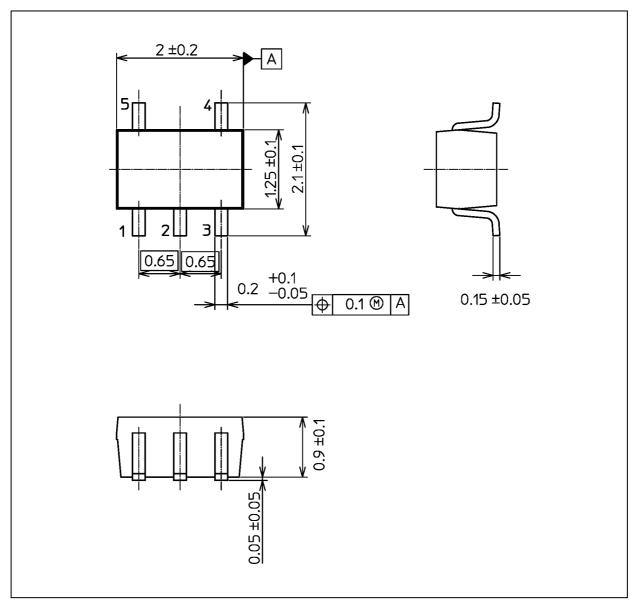
