The TC7W04 is a high speed C^2MOS Buffer fabricated with silicon gate C^2MOS technology.


The internal circuit is composed of 3 stages including buffer output, which enables high noise immunity and stable output.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.









AC Electrical Characteristics Test Circuit



Operating Current Consumption Test Circuit





