






Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking

#### 8. Moisture-Proof Packing


This device is packed in a moisture-proof laminated aluminum bag.

#### 8.1. Precautions for Transportation and Storage (Note)

- Avoid excessive vibration during transportation.
- Do not toss or drop the packed devices to avoid ripping of the bag.
- After opening the moisture-proof bag, the devices should be assembled within two weeks in an environment of 5°C to 30°C and RH70% or below. Perform reflow at most twice.
- The moisture-proof bag may be stored unopened for up to 24 months at 5°C to 30°C and RH90% or below.
- (5) If, upon opening the bag, the moisture indicator card shows humidity of 30% or above (the color of the 30% dot has changed from blue to pink) or the expiration date has passed, the devices should be baked as follows:


Baking conditions: 125°C for 48 hours.

Note: Since the tape materials are not heat-proof, devices should be placed on either heat-proof trays or aluminum magazines when baking.



The humidity indicator shows an approximate ambient humidity at 25 °C. If the ambient humidity is below 30 %, the color of all the indicator dots is blue. If, upon opening the bag, the color of the 30 % dot has changed from blue to pink, the devices should be baked before assembly.




Fig. 9.5 R<sub>DS(ON)</sub> - I<sub>D</sub>

Fig. 9.6 R<sub>DS(ON)</sub> - T<sub>a</sub>






Fig. 9.7 IDR - VDS




Fig. 9.9 Vth - Ta




Fig. 9.8 Capacitance - V<sub>DS</sub>




Fig. 9.10 Dynamic Input/Output Characteristics






Fig. 9.11  $r_{th}/R_{th(ch-c)} - t_w$  (Guaranteed Maximum)




Fig. 9.12 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)


Fig. 9.13 Safe Operating Area (Guaranteed Maximum)


