




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.3 I<sub>D</sub> - V<sub>GS</sub>




Fig. 8.5  $V_{DSS}$  -  $T_a$ 




Fig. 8.2 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.4 VDS - VGS




Fig. 8.6 R<sub>DS(ON)</sub> - I<sub>D</sub>






Fig. 8.7 R<sub>DS(ON)</sub> - T<sub>a</sub>





Fig. 8.9 C - V<sub>DS</sub>




Fig. 8.8 IDR - VDS




Fig. 8.10 V<sub>th</sub> - T<sub>a</sub>




Fig. 8.12 Eoss - V<sub>DS</sub>






Fig. 8.13 r<sub>th</sub> - t<sub>w</sub> (Guaranteed Maximum)




Fig. 8.14 E<sub>AS</sub> - T<sub>ch</sub> (Guaranteed Maximum)




Fig. 8.16 Test Circuit/Waveform




Fig. 8.15 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)




Fig. 8.17 I<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)





Fig. 8.18 Safe Operating Area (Guaranteed Maximum)
