




Fig. 6.2.1 Switching Time Test Circuit





Fig. 8.7 IDR - VDS






Fig. 8.11 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)




Fig. 8.8 Capacitance - V<sub>DS</sub>





Fig. 8.10 **Dynamic Input/Output Characteristics** 


